Be it known that the Legislature of the State of Delaware, did, on the twenty-fifth day of January, in the year of our Lord, one thousand nine hundred and eleven, at an election in due manner held, according to the form of the Act of the General Assembly of said State, in such case made and provided, chose Henry A. duPont to be a Senator from said State in the Senate of the United States, for the Constitutional term to commence on the fourth day of March next.

And Whereas, There is a strong tendency to waste and extravagance in all State institutions, on the principle that it is easy to be liberal with other people's money; a tendency which is intensified by the spirit of the age which sneers at prudent and honorable economy as mean and exalts extravagance as "progressive;" a tendency intensified also by the consequent fact that the popular trustee is the man who supports and "stands pat" with a profusive management.

And Whereas, By a comparison of numerous reports of the Institution since its establishment, it appears that the increase in attendance has been abnormal, compelling the belief that many are admitted to the Hospital who should be cared for elsewhere.

And Whereas, By a like comparison of like reports, it seems that there has been a gradual increase in an already high per capita cost—a fact which in conjunction with certain items of expense published in reports of the Institution, causes the conviction, that there is more or less profusion in the management.

Therefore be it Resolved by the House of Representatives, that while we cheerfully, and even gratefully vote for the appropriations for the maintenance of the Institution, we at the same time express our belief that there is need of greater care in the admission of inmates, and greater economy in the management.
