DELAWARE GRANDPARENTS RESPONSIBLE FOR THEIR GRANDCHILDREN

Thousands of children live in mixed-generation families solely with their grandparents in the state of Delaware. In 2000, there were 16,689 grandparents living in households with their grandchildren, which constitutes about 8% of all households with children under the age of 18. Approximately 4% (7,204) of grandparents in households with children under the age of 18 are financially responsible for their grandchildren. In the state, the areas with the highest percentage of intergenerational households include Wilmington with 16.2%, Wilmington Manor with 14%, Middletown and Selbyville with 12% of households. The lowest concentration of intergenerational families can be found in places such as Rehoboth (0%), Lewes (2%), and Newark (2 %).

When it comes to grandparents who live with their grandchildren


The U.S. Census bureau defines "grandparents responsible for grandchildren" as grandparents who have assumed financial responsibility for food, shelter, clothing, day care, etc. for their grandchildren on a temporary or permanent live-in basis

and who are financially responsible for their grandchildren, the highest concentration can be found in Selbyville (10%),Delmar (8%), Georgetown (8%). and Wilmington

(7%). The lowest percentage of grandparents responsible for their grandchildren is most obviously Rehoboth with 0%, where there are not even any children living in including families their grandparents. Hockessin (1%), and Newark (0.1%) also have a low concentration.

Of the 16,689 grandparents who live with their grandchildren, 43% are also financially responsible for them. Almost half of these grandparents have been financially responsible for their grandchildren for five or more years.

grandparents assuming financial as well as primary parenting roles, the stresses can be pronounced because of their developmental stage in life, family situation and the extra burden on resources. Also. as some grandparents are retired, heading towards retirement, the extra financial burden of rearing children can have an impact on their savings, or ability to retire as planned. It is important for grandparents in this situation to have support in their endeavors whether through support groups or other informal means, or with the help of state programs such as Medicaid and childcare subsidies.

The U.S. Census Bureau conducts a census of the population every ten years. The most recent was completed in April 2000. This series of reports highlights information most relevant for community leaders, policy makers, advocates, and others concerned with the status of children and families in Delaware.
