## TOUR OF HISTORIC AND PRESENT DAY LEWES, DELAWARE,

In Honor of Governor Richard C. McMullen and Members of the General Assembly,

#### March 31, 1937

- No. 1.—Entrance to town, (Left) OLD EBENEZER CEMETERY, one of the earliest burial grounds in Sussex County. Oldest grave, 1700.
- No. 2.—(Left) LEWES CCC CAMP. First camp in Delaware. Has been on mosquito control work in Sussex County since December, 1933. Captain Earle E. Ewing, Commanding Officer; John Travis, Superintendent. (All invited to stop for inspection.)
- No.3 —(Left) LEWES SCHOOL. In the distance beyond the cemetery to the left is the colored school.
- No. 4.—(Left)) BEEBE HOSPITAL OF SUSSEX COUNTY, INC., operated by two brother surgeons, Dr. James Beebe and Dr. Richard C. Beebe. One of the only six hospitals in Delaware on the accredited list of the American College of Surgeons. (New \$65,000 addition under construction in rear).
- No. 5.—Proceed into town on the street recently re-named SAVANNAH ROAD in the restoration plan of ancient street names. At right, corner of Savannah Road, King's Highway and Third Street, ZWAANENDAEL HOUSE, Museum and public library, built by the State of Delaware in 1932 to commemorate the first Dutch settlers who landed at Zwaanendael (Lewes) in 1631. This building is on the site of the Penn Charter School, one of the first girls' seminaries in the colonies.
- No. 6.—(Left) ZWANANENDAEL CLUB, on the corner, branch of the Federation of Women's Clubs. (Original bank building occupied by the Sussex Trust Co.).

  Turn right and proceed up King's Highway.
- No. 7.—(Left) VESSEL'S HOUSE, southeast corner in grove. Residence of Delaware's 15th Governor, Colonel David Hall, built about 1770. This was later the boyhood home of the Hon. Robert G. Houston, of Georgetown.

No. 8.—(Left) PRESBYTERIAN CHURCH. Original church built in 1707. Ancient gravestones in churchyard of Governors David Hall and Ebe Tunnell, and many early colonists.

(To left in distance may be seen Lewes Power & Water Plant and 100 foot standpipe.
(Right on Fourth Street.)

- No. 9.—(Left) Crossing Savannah Road, (State St.)) on the corner is a type of early home sheathed in cypress shingles, home of H. H. Hall.
- No. 10.—(Right) METHODIST EPISCOPAL CHURCH, built in 1911. Quaint early home to left.

  Turn right on Market Street and left onto Third Street.
- No. 11.—Good example of early type of homes, left (corner Market and Third).

  Down Third Street to KNITTING STREET, formerly known as Mulberry Street). Old records reveal this street, one of oldest in town, was originally called "Knitting Street", and the name is being restored.
- No. 12.—(Left) First Methodist Episcopal Church in Lewes, built in 1791. Corner Third and Knitting Streets. Now owned by Mrs. Mary Register and used as two-family house.

Continuing on Third Street to Cammomile section of negro residents.

Turn right into Ship Carpenter Street, (formerly Park Avenue). This street was originally called Ship Carpenter as here lived many of the carpenters engaged in the ship-building industry that flourished here through the 17th, 18th and 19th centuries. The street name is being restored.

- No. 13.—(Right) BEEBE HOUSE. Site of ancient artillery storehouse, War of 1812. Corner 2nd Street.

  Left on Pilot Town Road. Marsh lowlands being filled in by dredge working on the new \$230,000 inlet from Delaware Bay. On left side of this road may be seen many of the earliest homes of Delaware River pilots. New improved boulevard constructed by State Highway Department.
- No. 14.—(Left) ORTON HOUSE. Early home built in 1700. In cellar are iron barred windows where slave prisoners were kept. Brick slave hut in yard.

- No. 15.—(Left) HOME OF WILLIAM RUSSELL, tanner and lime-kiln owner, built about 1790. In rear of modern bungalow of present William Russell was the tannery and opposite old home on canal bank was lime-kiln. (Stones from old spring house heaped in pile on site of kiln. Along the canal were located old ship-building yards of early days.
- No. 16.—(Left) HICKMAN HOUSE. Fine example of early home with off-center gable, now occupied by negroes.
- No. 17.—(Right) SITE OF "FOUNTAIN OF YOUTH". An old spring that once furnished drinking water for earliest colonists, and said to have magic charm, is soon to be restored on this site.
- No. 18.—(Left) MAULL HOUSE. Early type of Dutch home.
- No. 19.—(Left) SCHELLINGER HOUSE, built about 1802. Home of William Schellinger, pilot. Now occupied by negroes.
- No. 20.—(Left) MAJOR HENRY FISHER HOME. Once one the most palatial residences in Sussex County, known as "Fisher's Paradise". From this house it is said that Caesar Rodney started his famous ride to Philadelphia, after being in Lewes to quell Tory uprisings.
- No. 21.—(Left) Brittingham's Dairy and residence.
- No. 22.—(Right) MONUMENT to David Pieterssen DeVries of Hoorn, Holland, leader of the Dutch expedition sailing from that port to settle Zwaanendael. Monument unveiled on September 22, 1909, by Baron Louden, Dutch Minister to the United States. Erected by the the State of Delaware on the site of the first colony in 1631. (Opposite monument, first burial ground in ancient Lewes).

The Great Marsh of William Penn lies in the distance to the northwest.

Return via Pilot Town Road to Second Street. End of Second Street, home of the late Dr. H. R. Burton, former U. S. Representative.

No. 23.—(Right) Home of Governor Ebe Tunnell, now owned by Mrs. Roman Tammany, member of the Lewes Tercentary Commission. Incidentally, Lewes has contributed six governors to the State: David Hall, Daniel Rodney, Caleb Rodney, Samuel Paynter, Joseph Maull and Ebe W. Tunnell.

- No. 24.—(Left) Home of Governor Daniel Rodney.
- No. 25.—(Right) RYVES HOLT HOUSE, oldest house in Lewes erected prior to 1685. Once an inn of colonial days and later the home of Chief Justice Ryves Holt. Bronze marker on front.
- No. 26.—(Right) Bronze marker in churchyard wall marks site of first court house in Sussex, erected about 1740. The first court house was authorized by Governor Andros in 1680 to be built of logs to cost 5000 pounds of tobacco.
- No. 27.—(Right) St. Peter's Protestant Episcopal Church, the first church, was built 1721, present church built 1854. Old graves in churchyard include tomb of Captain James Drew, Captain of the treasure sloop, DeBraak, who was drowned when the ship foundered in 1798 off Cape Henlopen.
- No. 28.—(Left) SITE OF OLD COUNTY JAIL (present Chambers Drug Store). In this jail Stephen Girard, Philadelphia merchant was thrown by the English Crown for non-payment of debts. Original foundation in rear of building.
- No. 29.—Through business section of present-day Lewes showing modern banking institutions and stores of merchants.
- No. 30.—(Left) INGRAM HOUSE—Over 200 years old.
- No. 31.—(Left) GRAVES STORE. In this building was one of the first girls' schools in Lewes, conducted by Miss Lydia Rodney.
- No. 32.—On Savannah Road opposite the end of Second Street, three old homes, originally one house. When separated they were designated as New Castle, Kent and Sussex. Now owned by Mrs. G. Clifton Maull, Captain Harry V. Lyons, and Mrs. George W. Roberts, built about 1776, separated about 1885.

Cross State Highway bridge from which one gets a good view of new yacht basin just finished.
Out Savannah Road toward Lewes Beach.

No. 33.—Road to right leads to Lewes Coast Guard Station, Naval Radio Station and historic site of Cape Henlopen Lighthouse. Improved road now being built by State Highway Department. Historic sand dunes can be seen in distance.

View of famous Delaware Breakwater. There are two stone breadwaters, the inner one begun in 1829 and the outer one in 1892. They provided 1,000 acres of safe anchorage for vessels of all sizes from all parts of the world. Maritime exchange located midway on the inner breakwater. Queen Anne Pier, destroyed in 1936 by ice jam, has been rebuilt. It is a popular rendezvous for fishermen.

Beach homes to left along bay front, where Lewes Yacht Club races are held in bay on Sunday afternoons between June and September.

Return along the Savannah Road and cross the Canal Bridge.

Turn right on Front Street.

- No. 34.—(Right) MEMORIAL PARK. Site of fort and battery emplacements used in defense of the town during Revolution and War of 1812. Two British naval guns on lower ramp used in War of 1812. Four large cannons on upper ramp contributed by government when fort was restored. Small six-pounder between four guns used during Civil War to celebrate Republican victories. To offset demonstrations at the time Lincoln was reelected, southern sympathizers seized it and buried it on the farm of William Russell, in Pilot Town, where it lay for fifty years until discovered and placed in the park shortly prior to the World War. Three-inch gun in cen-. ter of lower ramp was used during World War on submarine patrol in the North Sea. Contributed by Henlopen Post No. 5, American Legion of Lewes and Rehoboth.
- No. 35.—(Left) LEWES POSTOFFICE, opposite park, second floor headquarters of the Delaware Mosquito Control Commission.
- No. 36.—(Left) ROWLAND HOUSE. Built prior to 1797.

  Marker on side foundation shows where house was struck by cannon ball during bombardment of Lewes, during War of 1812.

Continue on Front Street to Market Street. Site of old ship chandler stores and early activities of the shipbrilding era.

No. 38.—Turn left into Market Street to Caesar Rodney Hotel.

This modern hostelry, owned by the Lewes Hotel Company and operated by Major Harry M. Stamford, was built on the site of the home of John Rodney, Lord High Sheriff under British King, a door of which was struck

by a cannon ball during the War of 1812. The door is now in the basement of St. Peter's Church.

The hotel was completely renovated last year and is the scene of many social events, conventions and banquets of local and state organizations and is your last stop of this tour of historic and present-day Lewes, where the Chamber of Commerce banquet will be held at 6:30 P. M.
