WHEREAS, the State Auditor's report for the fiscal year 1937-8, at page 199, shows that there was spent for the car inspection campaign the sum of Twenty-two Thousand Five Hundred Seventy Dollars and Forty-eight Cents (\$22,570.48); and

WHEREAS, it is currently reported that the sum spent for the present fiscal year for the car inspection campaign already exceeds the appropriated sum of Ten Thousand Dollars (\$10,-000.00); and

WHEREAS, it is reported that the appropriation to the Motor Vehicle Department of Ninety-seven Thousand Six Hundred Dollars (\$97,600.00) for the current fiscal year is now about expended and there will not be sufficient funds to carry on the work of the Department for the balance of the current fiscal year.

NOW, THEREFORE, BE IT RESOLVED by the Senate, that the Motor Vehicle Commissioner, or in his absence the Deputy Motor Vehicle Commissioner, shall report in writing to this Senate by noon of Thursday, March 23rd, next, the exact sum of money expended by the Motor Vehicle Department for the car inspection campaign during the fiscal year ending June 30th, 1938, and if said sum exceeds the appropriated sum of Ten Thousand Dollars (\$10,000.00) from what source and under what circumstances any excess over the appropriated sum was obtained and what Department or persons gave approval thereto. Further, that the said report shall contain a statement of the amount expended during the present fiscal year for the car inspection campaign, and likewise if said sum exceeds the appropriated sum of Ten Thousand Dollars (\$10,000.00) from what fund said excess was obtained and the Department or persons who gave approval thereto. Further, that said report shall contain a statement of the amounts expended for the current fiscal year to date by the Motor Vehicle Department and what balance there is on hand of the appropriated sum of Ninetyseven Thousand Six Hundred Dollars (\$97,600.00) for the balance of the current fiscal year.

AND BE IT FURTHER RESOLVED, That the Motor Vehicle Commissioner, or in his absence the Deputy Motor Vehicle Commissioner, report to this Senate a list of all State owned cars, including the make and model thereof, and by what Department, Bureau or officers the cars are owned.
