REPORT OF THE COMMITTEE ON RESOLUTIONS ADOPTED AT THE ANNUAL MEETING OF THE PENINSULA

HORTICULTURAL SOCIETY AT DOVER, DELAWARE, ON DECEMBER 15, 1944

WHEREAS, an emergency labor situation continues,

BE IT RESOLVED, that to help alleviate the farm labor shortage, this Society recommends that Congress appropriate a sum of money not in excess of that used in 1944 to carry out the emergency labor program of 1945.

WHEREAS, the certification of 1944 Southern grown tomato plants failed to measure up to proper certification,

BE IT RESOLVED, that the Peninsula Horticultural Society contact the proper authorities, requesting them to see that the tomato plants sold on the Peninsula as "Certified" be true to certification with respect to disease and count.

RESOLVED, that the Peninsula Horticultural Society support the claims made by Delaware apple growers for losses due to certain methods of fumigation supervised and recommended by the Federal Bureau of Entomology and Plant Quarantine for the control of Japanese beetles.

WHEREAS, Delaware and Maryland fruit growers have been saved thousands of dollars by the help of the U. S. Fish and Wildlife Service in reducing injury to fruit trees by rodents, and

WHEREAS, continued studies and assistance are desired in the development of better control methods for mice, rats, woodchucks, rabbits, and other wildlife injurious to the fruit industry as well as other agricultural crops, and

WHEREAS, federal assistance in the solution of these problems is now curtailed by a lack of cooperative funds from Delaware and Maryland, therefore,

BE IT RESOLVED, that the Peninsula Horticultural Society recommend establishment of a cooperative rodent control program between the U. S. Fish and Wildlife Service and the State Experiment Stations of Delaware and Maryland by providing \$6,000.00 State funds annually by each State for this work.

RESOLVED, that the Peninsula Horticultural Society urge the development of greenhouse facilities for the Delaware Agricultural Experiment Station as a part of the post-war development for the advancement of agriculture and that a State appropriation of \$75,000.00 for this purpose be urgently supported. WHEREAS, the Peninsula Horticultural Society has been the recipient of unusual hospitality in the city of Dover, through the cooperation of city officials, the State Department, Superintendent of Dover Schools for the use of cafeteria facilities, Fruitland Grange for the delicious and well served banquet, and the many public spirited citizens who gave of their time and talent.

BE IT RESOLVED, that the Peninsula Horticultural Society express its thanks and appreciation.

And Whereas, through recommendations in writing of the Board of Pardons sentences of the said Victor R. Ellacott, alias Charles Struthers, were commuted to expire on the first day of May, A. D. 1941.

And Whereas, all of the members of the Board of Pardons, after a full hearing, have recommended in writing that the said Victor R. Ellacott, alias Charles Struthers, be granted a full pardon, having fully set forth in said paper writing their reasons for such recommendation.

Now, Therefore, I, Walter W. Bacon, Governor of the State of Delaware, by virtue of the authority in me vested by the Constitution of the said State in that behalf, have granted and do hereby grant to the said Victor R. Ellacott, alias Charles Struthers, as recommended by all of the members of the Board of Pardons, a full pardon, of and from the crime of Robbery for which he was sentenced by the Court as aforesaid.

Dear Senator Buck:

Thank you for your letter of February 6, 1945, enclosing Senate Concurrent Resolution No. 10, passed by the General Assembly of Delaware, together with letter from Governor Bacon.

I am sure that Judge Vinson agrees heartily with the objective of this resolution—namely, to secure better coordination of the efforts and operation of government agencies which deal with poultry. I do not think that he feels, however, that it would be possible for him to name a separate coordinator for each commodity in each state or area which produces such commodity. Such an action on his part would involve the creation of a large staff, and would inevitably result in a duplication of work now carried on by the Office of Price Administration and the War Food Administration. Judge Vinson understands his function to be primarily that of determining broad issues of economic policy rather than the supervision of administrative agencies in the details of their work.

If the basic policies which have been pursued by government agencies in connection with poultry are inconsistent or have operated in conflict with each other, I am sure that Judge Vinson will be glad to receive from those interested in poultry production a memorandum setting forth their specific suggestions as to what policies might be altered or improved.

Such a memorandum would receive his earnest consideration.
