Mr. Wright, on motion for leave, introduced Senate Joint Resolution No. 6, entitled:

SENATE JOINT RESOLUTION NO. 6

PROVIDING FOR THE ASSENT OF THE STATE OF DELAWARE TO THE PROVISIONS AND REQUIREMENTS OF AN ACT OF CONGRESS ENTITLED "AN ACT TO PROVIDE FOR RESEARCH INTO THE BASIC LAWS AND PRINCIPLES RELATING TO AGRICULTURE AND TO PROVIDE FOR THE FURTHER DEVELOPMENT OF COOPERATIVE EXTENSION WORK IN AGRICULTURE AND FOR THE MORE COMPLETE ENDOWMENT AND SUPPORT OF LAND GRANT COLLEGES" IN THE SEVERAL STATES RECEIVING THE BENEFITS OF THE ACT ENTITLED "AN ACT DONATING PUBLIC LANDS TO THE SEVERAL STATES AND TERRITORIES WHICH MAY PROVIDE COLLEGES FOR THE BENEFIT OF AGRICULTURE AND MECHANIC ARTS," APPROVED JULY 2, 1862, AND OF ALL ACTS SUPPLEMENTARY THERETO.

WHEREAS the 74th Congress of the United States has passed An Act, designated as H. R. 7160, approved by the President, June 29, 1935, designated as An Act to provide for research into the basic laws and principles relating to Agriculture and to provide for the further development of Cooperative Extension Work and the more complete endowment and support of land grant colleges; and

WHEREAS it is provided by Title I and Sections 21 and 22 of Title II of the Act aforesaid that the grants of moneys authorized by the Act shall be paid to each State which by action of its legislature assents to the provisions of the Act; therefore,

BE IT RESOLVED by the Senate of the State of Delaware, the House of Representatives concurring therein, that the assent of the State of Delaware be and is hereby given to the provisions and requirements of said Act and that the Trustees of the University of Delaware be and they are hereby authorized and empowered to receive the grants of moneys appropriated under said Act and in accordance with the provisions thereof. And

BE IT FURTHER RESOLVED that two approved copies of this resolution be sent to the Secretary of Agriculture.

Which was given first and second reading, the second by title only, and referred to the Committee on Agriculture.

Mr. Poore, on motion for leave, introduced Senate Joint Resolution No. 7, entitled:

SENATE JOINT RESOLUTION NO. 7

APPROVING THE PROVISIONS OF A BILL INTRODUCED INTO CONGRESS RELATIVE TO THE CONTROL AND ERADICATION OF NOXIOUS WEEDS AND RECOMMENDING THE SUPPORT THEREOF BY THE SENATORS AND REPRESENTATIVE IN CONGRESS FROM THIS STATE.

WHEREAS, there has been introduced into the current session of Congress a bill known as H. B. 4009, entitled "A bill to provide for the general welfare by establishing a system of Federal benefits and by enabling the several States to make more adequate provision for the control and the eradication of noxious weeds; to conserve and protect the agricultural resources of the several States and of the United States; to empower the Secretary of Agriculture to make certain rules and regulations and prescribe conditions; to raise revenue and for other purposes;" and,

WHEREAS, it is the feeling of the Senate and the House of Representatives of the State of Delaware that said Bill has a worthy purpose and should be supported by the Senators and member of Congress from this State; now, therefore,

BE IT RESOLVED, by the Senate of the State of Delaware, the House of Representatives concurring therein, that the Senate and House of Representative of the State of Delaware approve the said Bill recited in the preamble hereof and recommend the support thereof by the Honorable John G. Townsend, Jr., and the Honorable James H. Hughes, Senators from the State of Delaware, and the Honorable William A. Allen, Representative in Congress from the State of Delaware.

Which was given first and second reading, the second by title only, and referred to the Committee on Agriculture.

An Act to amend Chapter 92 of the Revised Code of Delaware, 1935, relating to the Execution of certain Legal Instruments by Home Owners Loan Corporation.

Which was given first and second reading, the second by title only, and referred to the Committee on Revised Statutes.

Mr. Poore, on motion for leave, introduced Senate Bill No. 168, entitled:

An Act to amend Chapter 165 of the Revised Code of Delaware, 1935, relating to Motor Vehicles by fixing the Minimum Age for Chauffeurs and Operators at Eighteen Years.

Which was given first and second reading, the second by title, only, and referred to the Committee on Buildings and Highways.

Mr. Poore, on motion for leave, introduced Senate Bill No. 169, entitled:

An Act authorizing, empowering and directing the Levy Court of Kent County to take over and maintain Ditches in Kent County and Establishing Revenue therefor.

Which was given first and second reading, the second by title, only, and referred to the Committee on Buildings and Highways.

Mr. Poore, on motion for leave, introduced Senate Bill No. 170, entitled:

An Act to amend Article 19, Chapter 6, of the Revised Code of Delaware, 1935, relating to State Revenue by providing for distribution of a part of the Gasoline Tax to the City or Town in which it is collected.

Which was given first and second reading, the second by title, only, and referred to the Committee on Buildings and Highways.

Mr. Poore, on motion for leave, introduced Senate Bill No. 171, entitled:

An Act providing for the Equipment of Trucks hauling Junk on the Highways.

Which was given first and second reading, the second by title, only, and referred to the Committee on Buildings and Highways.

Mr. Poore, on motion for leave, introduced Senate Bill No. 172, entitled:

An Act to provide for the appointment of a Warden for the Kent County Jail.

Which was given first and second reading, the second by title only, and referred to the Committee on Judiciary.

Mr. Poore, on motion for leave, introduced Senate Bill No. 173, entitled:

An Act prohibiting the Parking by State Employees of their Automobiles on the Dover Green.

Which was given first and second reading, the second by title, only, and referred to the Committee on Buildings and Highways.

Mr. Poore, on motion for leave, introduced Senate Bill No. 174, entitled:

An Act to amend Chapter 53 of the Revised Code of Delaware, 1935, relating to the Salary of the Sheriff of Kent County.

Which was given first and second reading, the second by title only, and referred to the Committee on Miscellaneous.

Mr. Poore, on motion for leave, introduced Senate Bill No. 175, entitled:

An Act to amend Chapter 43 of the Revised Code of Delaware, 1935, relating to Levy Courts by abolishing the Levy Courts of the respective Counties within the State and placing the County Governments of the respective Counties in the Clerks of the Peace and County Comptrollers of the respective Counties.

Which was given first and second reading, the second by title only, and referred to the Committee on Miscellaneous.

On motion for leave, Mr. Davis introduced Senate Resolution No. 29, entitled:

SENATE RESOLUTION NO. 29

WHEREAS there exists in Kent County a certain dirt road leading from the Houston-Williamsville Road to the Milford-Williamsville Road in Milford Hundred, that the said road is not a public highway of the State of Delaware but has been used by the people of Delaware for a period of fifty years and upwards, that the said road is neither maintained nor repaired by the Levy Court or the State Highway Department. And

WHEREAS the owners of the land over which the said road passes and the owners of the land adjacent to the said road are willing to give to the State of Delaware all right and title that they, the said property owners, have in said portion of the road, and

WHEREAS it would be of great benefit to the citizens of the State of Delaware living thereby if said road was taken over by the State of Delaware and made part of the State Roads now controlled by the State Highway Department,

BE IT RESOLVED by the Senate of the State of Delaware that the State Highway Department be directed to negotiate with the owners of the land over which the above mentioned road passes and the owners of the land adjacent to said road for the purpose of obtaining title to said road. If and when the State Highway Department obtains title to said road the State Highway Department shall then cause to be made a road leading from the Houston-Williamsville Road to the Milford-Williamsville Road and said road to be a part of the highway system of the State of Delaware and to be maintained by the State Highway Department.

Upon motion the resolution was taken up for consideration in order to pass the Senate.

Mr. Matthews, on motion for leave, introduced Senate Bill No. 176, entitled:

An Act to amend Chapter 8 of the Revised Code of Delaware, 1935, relating to Public Arms and Defense.

Which was given first and second reading, the second by title only, and referred to the Committee on Revised Statutes.

Mr. Matthews, on motion for leave, introduced Senate Bill No. 177, entitled:

An Act authorizing the making of new Indices for the Deed Records in the Recorder's Office for Kent County.

Which was given first and second reading, the second by title only, and referred to the Committee on Miscellaneous.

Mr. Hannam, on motion for leave, introduced Senate Bill No. 178, entitled:

An Act to amend Chapter 71 of the Revised Code of Delaware, 1935, relating to Free Public Schools.

Which was given first and second reading, the second by title only, and referred to the Committee on Education.

Mr. Davis by request, on motion for leave, introduced Senate Bill No. 179, entitled:

An Act appropriating certain moneys out of State Highway Fund for the purpose of erecting and constructing a bridge over Murderkill River connecting the Town of Bowers with South Bowers in Kent County.

Which was given first and second reading, the second by title, only, and referred to the Committee on Buildings and Highways.

Mr. Davis by request, on motion for leave, introduced Senate Bill No. 180, entitled:

An Act authorizing the State Highway Department to take over the Management and Control of Private Roads heretofore or hereafter dedicated to Public Use.

Which was given first and second reading, the second by title, only, and referred to the Committee on Buildings and Highways.

Mr. Thomas, on motion for leave, introduced Senate Bill No. 181, entitled:

An Act to amend Chapter 21 of the Revised Code of Delaware, 1935, relating to State Board of Agriculture by repealing the Provisions of said Chapter relating to the Grading, Marking and Sale of Apples in closed packages.

Which was given first and second reading, the second by title only, and referred to the Committee on Agriculture.

Mr. Thomas, on motion for leave, introduced Senate Bill No. 182, entitled:

An Act to amend Chapter 74 of the Revised Code of Delaware, 1935, repealing the Provision relating to the Catching of Eels in Kent County during certain periods of the year.

Which was given first and second reading, the second by title only, and referred to the Committee on Fish, Oysters and Game.

Mr. Moody, on motion for leave, introduced Senate Bill No. 183, entitled:

An Act authorizing the Town of Middletown to establish a Sewer System and other Improvements and to secure the necessary land or right of way for the same.

An Act to provide for a Lottery by the Levy Court of New Castle County for purposes of all form of Relief.

Mr. Simonton, on motion for leave, introduced Senate Bill No. 186, entitled:

An Act authorizing the State Old Age Welfare Commission, of the State of Delaware, to acquire the property of the Minqua-dale Home.

Which was given first and second reading, the second by title only, and referred to the Committee on Finance.

Mr. Simonton, on motion for leave, introduced Senate Bill No. 187, entitled:

An Act to amend An Act entitled: An Act to create the State Old Age Welfare Commission; to define the Powers and Duties of said Commission; to provide for the assistance of Old Age Persons through the agency of said Commission, under certain limitations and restrictions; to make appropriations of Public Funds for carrying out the purposes of this Act; and to prescribe Penalties for the Violation of its Provisions.

Which was given first and second reading, the second by title only, and referred to the Committee on Finance.

Mr. Simonton, on motion for leave, introduced Senate Bill No. 188, entitled:

An Act to amend Chapter 168, Revised Code of Delaware, 1935, relating to Regional Planning.

Which was given first and second reading, the second by title only, and referred to the Committee on Finance.

The bill is a dangerous one as we see it, and will incur no end of expense to the State if the provisions are carried out. An extra commission, survey for valuation of property, determining training and qualifications of men, tracing characters of members, financial statements and checking same, all add to the expense of distributing a fund much larger than has ever been asked for before.

We object to the placing of such great power in a three-man commission and only one member a Volunteer Fireman. We can see no virtue in extending greater help to the larger companies, while the companies in smaller towns need this assistance to enable them to carry on.

We favor the \$500 appropriation which we have been receiving annually for several years, and will thank you to use your good influence to the end the bill with this provision is passed by the Senate.

Dear Governor McMullen:

The National Society of the Colonial Dames of America in the State of Delaware, at its last meeting, unanimously adopted the following resolution:

WHEREAS, the year, 1938, will mark the Three Hundredth Anniversary of the first permanent white settlement upon Delaware soil, a settlement which was made by the Swedes on the banks of the Christiana River on the site of the present City of Wilmington, at a place called "THE ROCKS," and which was the first settlement of the colony of New Sweden, and

WHEREAS, this settlement was the beginning of a permanent government for the earliest permanent inhabitants of the present State of Delaware as well as of the present State of Pennsylvania and of western New Jersey, and

WHEREAS, the people of Sweden, by popular subscription are raising a fund of \$50,000 to provide and present to the people of Delaware a noble monument, designed by Carl Milles, a world famous sculptor, to be erected at "THE ROCKS" in commemoration of this historical event,

RESOLVED, that the National Society of the Colonial Dames of America, in the State of Delaware, respectfully request and do urge that the General Assembly of the State of Delaware do make some provision for the acquisition of "THE ROCKS" and a suitable area around them for this purpose.

Let us hope that the people of Delaware are at least as much Delaware-minded as concerns their colonial history as are the people of a friendly foreign country, Sweden.

Dear Sir:

A bill, which I understand is identified as Senate Bill No. 135, to repeal the law providing for bounties on the heads of hawks, has been introduced in the Senate, and I am writing to you to urge most earnestly that it be passed.

Extensive research by scientists of the United States Department of Agriculture and others, based on the examination of the contents of thousands of stomachs, has established that the food habits of the various kinds of hawks vary greatly. The results show that the damage done by hawks is confined to only a few species and that many species are among our most valuable birds, principally in the control of destructive rodents like the meadow mouse.

New Jersey, with laws based on a consideration of these facts, offers no bounties on hawks and protects by law all but the really destructive species. Pennsylvania, with one of the best wild life management systems in the country, offers a bounty only on the goshawk, a very destructive hawk which visits Delaware very rarely and only in winter. Our Delaware law, which encourages the indiscriminate killing of all species, is wholly out of harmony with modern knowledge and practice.
