

A new set of wheels

Family-owned bike shop adds Wilmington location

Wooden Wheels Bike Shop opened in the mid 1970s as one of only a handful of BMX bike-specialty shops in the country. The store grew to include skateboards and footwear in the 1970s and mountain bikes in the 1980s, and eventually evolved into a full-service shop.

The shop maintained its reputation as a quality bike shop for years, attracting people from all along the East Coast. As other bicycle stores emerged in the region, the store's staff focused on serving its Newark community customers, said store manager Tom Harvey.

He said the store has seen many loyal customers come in over the years.

"We're dealing with generations of customers now," he said.

Today, Wooden Wheels is Delaware's largest fam-

The owners of two local boutiques traded in their original Main Street locations this summer and are now selling their clothing and accessories at new spots downtown.

Moxie Boutique and Gecko Fashions are both still on Main Street, but their owners each said they chose to move their store to a new location that better facilitates the shopping experience.

Gecko Fashions owner Kay Snelling celebrated her store's last day at 146 E. Main St. with some of her employees and customers June 30 with lemonade, snacks from Klondike Kate's and mini cupcakes from SAS

Cupcakes. The store will officially reopen this Sunday at its new address, 282 E. Main St. Suite 2 in Market East Plaza, close to Mojo on Main.

Snelling said she is looking forward to the new location because it feels more intimate and boutique-like.

"I'm looking forward to new customers, current clients finding me, and the positive energy here," Snelling said.

Last month, Moxie Boutique settled into a new spot on Main Street with a better layout for merchandise and a nearby parking lot, said store owner Cari Woolf.

Moxie Boutique made the move from 48 E. Main St. to a spot in Trader's Alley at 165 E. Main St., previously occupied by US Optical. The store officially re-opened for business June 19.

Amazon.com to host job fair in Newark Saturday

Amazon.com will host a job fair Saturday to give area residents a chance to apply for jobs at the Internet retail giant's Middletown warehouse, slated to open this fall.

The event will be held from 9 a.m. to 3 p.m. at the Embassy Suites hotel on South College Avenue in Newark.

Amazon has openings for managers and warehouse workers, as well as specialty positions such as data technicians and finance professionals. Both entry-level jobs and positions requiring experience are available.

The 1.2-million-square-

foot distribution center is expected to employ 850 people, with another 1,000 temporary jobs added during the holiday season.

"It's a huge facility," Middletown spokeswoman Kristen Krenzer said earlier this year. "We could put four of our Walmarts in the bottom level, plus one more Walmart on the mezzanine."

The distribution center is also expected to be a catalyst for more job growth as other companies move to Middletown.

"We're really excited about it," Krenzer said. "It not only brings new jobs but also auxiliary jobs — all the businesses that will come

here for the lunch crowd, dinner crowd and to support Amazon."

Chick-fil-A has already committed to open in Middletown, and officials have heard from other restaurants and stores also expressing an interest, Krenzer said.

WSFS Bank opens Kirkwood Highway branch

WSFS Bank opened its newest branch and regional headquarters last month in Midway Shopping Center, at the corner of Kirkwood Highway and Limestone Road.

The new location marks the 40th branch for WSFS, the seventh-oldest bank in the country.

The building stands on a former brownfield site, which WSFS cleaned up using funding from a state grant.

Gov. Jack Markell and other state dignitaries were on hand Thursday for the bank's grand-opening ceremony.

"WSFS's new regional headquarters is a prime example of how investing in brownfield cleanup and redevelopment is

strengthening our economy and environment," Markell said. "Making a project like this happen requires collaboration among many partners but when it's done, the community benefits significantly. The state and private investments made here are providing jobs, economic growth, and a safer and healthier revitalized property."

Police: Man assaults victim with axe handle

Suspect was jailed in 2008 for brutal razor-blade attack



New Castle County Police arrested Ethan A. Younce, 23, of Elkton last Friday for allegedly assaulting another man with the wooden handle of an axe in the victim's Newark home and then robbing him late last month, police said.

A spokesman for Cecil County Sheriff's Office confirmed Monday that Younce is the same man

imprisoned in 2009 after pleading guilty to cutting open another man's rectum with a razor blade in Elkton; prosecutors said he did it because he believed the victim was hiding drugs or money.

Younce faced attempted second-degree murder charges in that case, but those charges were dropped as part of a plea agreement reached between Younce and his attorney, William F. Riddle, and Deputy State's Attorney Michael J. Halter.

In that case, Younce served two and a half years

of a three-year sentence in Cecil County Detention Center before retired Cecil County Circuit Judge O. Robert Lidums approved Younce's request to be moved to a drug-rehab facility last summer.

On June 29, 2012, Younce was apprehended in Maryland for a May 4 incident that violated the terms of his probation in the aforementioned case, said Lt. Michael Holmes, spokesman for the Cecil County Sheriff's Office.

Younce was extradited to Delaware on Friday, July 6, at which time investigators were able to confirm his involvement in the

Newark crime that happened the night of June 27, said New Castle County Police spokesman Cpl. John Weglarz.

Around 9 p.m. that night, New Castle County Police responded to the community of Rosetree Hunt in Newark for a reported robbery that had just occurred.

When officers arrived, they learned that a 24-year-old Newark man had been assaulted by an acquaintance, was suffering from injuries to his head, and that emergency personnel had taken him to Christiana Hospital for treatment after he had called 9-1-1 from an undisclosed location.

An investigation revealed that the suspect, later identified as Younce, had assaulted the victim inside the home and had fled after taking cash from the victim. The assault left the victim hospitalized with multiple head injuries, Weglarz said.

New Castle County Police charged Younce with robbery in the first degree and possession of a deadly weapon during the commission of a felony. He was arraigned and released on \$50,000 unsecured bond.

Armed robber strikes two Bear businesses

Troopers are investigating the armed robberies of two Bear businesses that occurred Monday, July 9 within 90 minutes of each other. Descriptions of the suspect have led detectives to believe the same man might have committed both crimes, said Delaware State Police Sgt. Paul Shavack.

The first incident happened around 6:30 p.m. at Super Dry Cleaners at 1945 Pulaski Highway when a suspect entered the business armed with a handgun and

confronted the 59-year-old male employee who was at the sales counter, Shavack said.

The suspect pointed the handgun at the employee and demanded money. The victim did not comply and ran towards the rear of the store. The suspect fled the business empty-handed in an unknown direction. There were no injuries as a result of the incident.

Shavack said Tuesday that although no one was hurt in the dry-cleaners incident, anyone confronted by an armed robber should comply with his or her demands.

"If you don't comply, the suspect could get agitated and the confrontation could become physical very quickly," Shavack said.

A victim should try to take a mental note of the clothing a robber is wearing and/or any physical attributes that could help detectives find him or her, Shavack said.

The suspect in this incident is described as a white male, unknown age, between 5 feet 7 and 5 feet 11 inches tall, 145-150 pounds with an average build. He was last seen wearing a tan or brown shirt, shorts, dark-colored hat and dark

sunglasses and was armed with an unknown type handgun.

The second incident happened around 7:50 p.m. July 9 at Holiday Hair Salon in the Eden Square Shopping Center. A suspect with a similar description as the first incident entered the business armed with a handgun and confronted two female employees, aged 23 and 33.

The suspect pointed the handgun at both victims and demanded money, and the employees turned over an undisclosed amount of cash. The suspect fled the business on foot in an unknown direction. There were

no injuries as a result of this incident. Surveillance photos not available at this time.

Man robbed at gunpoint at Newark Wawa

A 69-year-old Newark man was robbed at gunpoint and assaulted early Sunday morning in the parking lot of the Wawa convenience store at 1605 Pulaski Highway in Newark, state police said.

Troopers are still investigating the incident, which occurred around 3:21 a.m. Police said the victim had parked his car in the Wawa parking lot and left to enter the store when a suspect displayed an unknown type of handgun and demanded money. The suspect struck the victim in the head with the handgun and removed personal property from the victim's vehicle before fleeing the parking lot on foot towards Glasgow Avenue, police said.

The victim was transported to the Christiana Hospital for minor inju-

ries. Information about his treatment and disposition status is unknown at this time.

The suspect is described as a black male, 16 to 18 years old, 5 feet 2 inches tall with a thin build, about 130 pounds. He was last seen wearing a long, white t-shirt and was armed with an unknown type handgun.

Police said no surveillance footage is available at this time.

Cleaning lady charged in Hockessin thefts

New Castle County Detectives have arrested a 45-year-old woman for allegedly stealing items from a home she had been hired to clean.

Jacqueline Cuomo, 45 of Wilmington, was arrested and charged with felony theft last week following an investigation that started last month.

On June 22, detectives began investigating reports of a theft at a residence in Wellington Hills in Hockessin after a male victim said he suspected his maid had been stealing items from his home.

He told detectives that Cuomo had been his maid since January and that he had noticed things missing from his residence, includ-

ing prescription medication, jewelry and cash.

Further investigation confirmed that Cuomo had pawned items at a local pawn shop between April and June of this year and that some of those items belonged to the victim.

Cuomo was arrested July 5 and charged with felony theft. She was arraigned and released on \$2,000 unsecured bond and ordered to have no contact with the victim.

Traffic stop leads to drug arrest and money seizure

New Castle County Police arrested Ralph

Lloyd, 33, of Phyllis Drive in Newark last Thursday and charged him with traffic and drug offenses after police found him in possession of prescription pills and proceeds from the sale of drugs while conducting a vehicle stop.

Just before 11 p.m. Thursday officer David DiNardo was on routine patrol in the area of Phyllis Drive and Darwin Drive when he observed a blue Honda Accord with a registration violation. He stopped the car on Phyllis Drive made contact with the driver, later identified as Ralph Lloyd.

At that time, DiNardo learned that Lloyd did not have his license, nor could he provide the registration and insurance information for the

vehicle. After exiting the vehicle, Lloyd was found to be in possession of a large amount of cash and a pill bottle that did not have a label and contained three pills of the prescription medication Suboxone.

A search of the vehicle revealed two other unlabeled pill bottles containing 45 Oxycodone pills and 21 Opana pills hidden under the driver's seat.

The officer found \$497 of suspected drug money on Lloyd, and called Cpl. Joseph Krajewski and his canine partner "Eros" to assist in the investigation.

Eros conducted a money sniff that yielded a positive indication for the presence of a controlled dangerous substance and the money was seized.

Lloyd was arrested and charged with possession with the intent to deliver oxycodone pills, possession of oxycodone

Car crashes into home, residents displaced

A 76-year-old New Castle man drove through a neighbor's house Monday after he pressed the gas pedal thinking it was the brake pedal while moving his car so he could mow the lawn, police said.

New Castle County Traffic Services Unit is investigating the crash, which happened in the New Castle community of Garfield Park.

No one was inside the home when the crash occurred and the driver was not injured.

A county building inspector responded to the scene

and determined the neighbor's home to be unsafe and unfit for habitation due to the structural damage caused by the car wreck, police said. The driver was cited for careless driving.

Around 5:07 p.m. Monday, county police and emergency personnel from the Minquadale and Holloway Terrace fire companies responded to the 100 block of Donhaven Drive for a report of a car that had crashed into a residence.

When police arrived, they found a 1993 Buick Roadmaster partially protruding from the home's left side, where the dining room had been.

The investigation revealed the driver had pressed the accelerator instead of the brake pedal, as he was moving his car. As a result, his car traveled across the street and struck a vehicle parked in the driveway of a neighbor's home before partially entering the residence.

arrested a Pennsylvania man last Tuesday after he allegedly burglarized a north Wilmington church earlier that morning.

Police said Michael G. McGowan, 52, of Pottstown, Pa., was arrested and charged

with three counts each of third-degree burglary, theft and criminal mischief for allegedly breaking into the Church of the Holy Child, at 2500 Naamans Road in Wilmington, three different times and stealing money from the church's collection boxes.

The investigation began around 6:15 a.m. this morning after troopers were called to the church for a report of an alarm.

Upon their arrival, troopers discovered that someone had pried open the doors of the church and broke into several collection boxes, removing an undisclosed amount of cash before fleeing from the church.

Troopers reviewed sur-

veillance footage from the church and were able to obtain a description of the suspect.

A broadcast was issued over police radio. A short time later, troopers saw a male suspect later identified as Michael G. McGowan, walking on Route 202 about one mile from the church. McGowan closely resembled the suspect captured on the church-surveillance cameras, so police took him into custody.

Through further investigation, troopers determined that McGowan had also burglarized the same church on Monday, July 2 and Monday, June 25. In each incident, McGowan had pried open the church's doors and removed money from the collection boxes.

McGowan was arraigned at JP Court 2 and committed to the Department of Corrections for lack of bail.

Correctional officer arrested for having sex with inmate

Delaware State Police arrested a correctional officer last week on charges of having sexual relations with a female prisoner.

State Police Detectives began an investigation into the allegations on June 29 after a 22-year-old female prisoner disclosed to officials at Sussex Correctional Institution in Georgetown

that she and Daniel L. Mann, 49, of Dover, had become involved in a sexual relationship.

The woman reported that shortly after she entered into the work-release program on March 7, she and Mann, who worked in the unit, began a friendly relationship that soon became sexual in nature on three separate occasions. Each encounter occurred in the facility where the victim was housed.

Mann was arrested Tuesday at Troop 4 in Georgetown on three counts of sexual relations in a detention facility. He was arraigned at JP Court 2 and is committed to SCI on \$4,500 cash bail.

Police issue 'Gold Alert' for missing Newark man

New Castle County Police are searching for information regarding the whereabouts of Joshua Rickard, 22, of Newark, who was last seen last week.

Rickard's last known address was in the 3000 block of Rosetree Lane in the Newark community of Rosetree Hunt.

He is described as a white male, 6 feet 8 inches tall, 370 pounds, with red hair and blue eyes. He was last seen wearing a white T-shirt, black pants and a black baseball cap. His medical status is such that there is a real concern for his welfare.

New Castle County Police spokesman Cpl.

John Weglarz said that due to privacy laws, he could not comment further on the specifics of Rickard's situation, but he said a Gold Alert is issued based on certain parameters such as if a missing person is, for instance, suicidal or is an elderly person with dementia.

Weglarz said Rickard's former roommate first reported Rickard missing at 2 a.m. last Tuesday after Rickard fled on foot from the aforementioned residence just before midnight.

At 2:55 a.m. last Friday, Rickard called his former roommate and said he was on his way to Ocean City, Md. After following up on the phone call to his former roommate, police learned that Rickard had used another friend's cellular to make the call. Police then discovered that Rickard had left a residence in the 1000 block of Oxer Circle on foot early this morning.

Assisting officers and a canine team canvassed the surrounding area, but they did not find Rickard.





Police arrest two for Newark construction-site burglaries

Still looking for third suspect that got away

New Castle County Police arrested two New Castle residents last Tuesday after they were caught allegedly burglarizing vacant homes in a community still under

construction near Chapman Road in Newark.

County police arrested Scott Shirk, 34, and Taylor Honey, 23, both of New Castle, after a concerned citizen called 9-1-1 and reported seeing two men remove large items from several vacant homes under construction and place them into a dark-colored pickup truck occupied by a female driver, said police department spokesman Cpl. John Weglarz Sr.

When county police responded to the site, at Jacobson Circle in the Hudson Village community off Chapman Road, both male subjects immediately fled the area, police said. One

of subjects, later identified as Scott Shirk, was caught while attempting to hide underneath a construction trailer.

Police apprehended the female driver, later identified as Taylor Honey, inside the truck.


Assisting officers and a canine team responded to the scene, but were unable to track down the third suspect, later identified as Christopher Shirk, 36, of New Castle, Weglarz said.

Police discovered the bed of the truck was filled with a large amount metal ductwork from an air conditioner, which was recovered and returned to the victim.

New Castle County man tests positive for VRSA

A 70-year-old New Castle County man has become the third Delawarean to develop a vancomycin-resistant Staphylococcus aureus (VRSA) infection in two years, according to officials from the Delaware Division of Public Health (DPH).

The infection, discovered last week, is similar to a normal staph infection, but is resistant to antibiot-

ics normally used to treat staph cases, said Dr. Rick Hong, medical director in the Office of Preparedness.

Other Food and Drug Administration (FDA) approved drugs have been successful in treating the infection, he said.

The first and second cases of VRSA were positively identified in 2010. This is the 13th VRSA case in the nation since 2002.

Hong said he could not comment more specifi-

cally on where the New Castle County man lives or at which health-care facility his infection was discovered. The patient was being treated for the infection as an outpatient.

Hong did say that there was no geographical connection between the three Delaware cases.

But just in case, he said, the DPH at this point is educating physicians about the infection and asking them to be especially aware of any

patients' infections that seem to not be healing with normal antibiotics.

People that develop VRSA infections usually have several underlying health conditions such as diabetes or kidney disease or have had previous staph infections, been hospitalized, had tubes going into their bodies or recent exposure to vancomycin or other microbial agents, according to findings from the Center for Disease Control.

DPH's investigations conclude that all of the Delaware VRSA cases were being medically treated for multiple underlying health conditions.

While the CDC has not documented VRSA to be communicable, as a precaution DPH is investigating people who have been in close contact with the affected individuals.

Hong said the main concern of the DPH at this point is reminding

Delaware health-care professionals about appropriate infection-control practices such as frequent hand washing and masks when medically indicated, to reduce the spread of VRSA. Judicious use of antibiotics will also help to reduce the development and spread of resistant organisms such as VRSA.



Filling your pantry, freezer with this summer's harvest

Are you already thinking "What am I going to do with all of that produce?"

Many families have started gardens this year, and the harvest is close to being in full swing with yummy tomatoes, peppers, corn and beans. It can be a challenge eating them all up as soon as they come in the door. Freezing or canning your harvest is the best way to "put foods up" for later.

We have had many calls already from people interested in learning how to preserve food safely. Canning can be daunting if you've never done it before. And with the risk of botulism, it's important to get it right.

I've seen some downright wrong recipes and techniques on the web. It's important to follow tested recipes because test labs have reviewed the ingredients and procedures. By following the recipes and following the steps, you reduce the chances of Clostridium botulinum reproduction and thus the development of the neurotoxin that can cause severe illness and even death.

For approved recipes, visit the National Center for Home Food Preservation website at <http://www.uga.edu/nchfp/> or find the USDA Complete Guide to Home Canning at http://www.uga.edu/nchfp/publications/publications_usda.html. Ball has some excellent tested recipes as well.

If canning is something you don't want to take on, freezing may be your best bet. The two reference websites above also provide guidance on effective freezing. Though there isn't the concern about botulism when freezing, there are

techniques that will ensure product quality over time. Blanching is one strategy that kills enzymes and will reduce discoloration of products. Each product has different blanch times so be sure to review them. Packing products tightly and reducing air within the container also helps reduce freezer burn. 

Owner plans to reopen Middletown Friendly's this fall

Restaurant destroyed in blaze last month

Brian Myers, owner of six Friendly's restaurants in New Castle County, said he plans to rebuild his Middletown Friendly's business, which burned to the ground late last month in an accidental fire. Myers said he hopes to have the restaurant back up and running by Nov. 1.

"I'm targeting November; I know that's a little optimistic, but that's what we're hoping for, and I'm definitely sure we'll have a grand opening (event) of some

kind," Myers said Monday.

Patrons and staff were inside the restaurant, on Dove Run Center Drive in Middletown, around 3:30 p.m. Wednesday, June 27 when the fire broke out. State fire investigators later determined that the fire had started in the mulch outside the building and spread quickly to the roof, said Robert L. Fox, Delaware's chief deputy fire marshal.

Friendly's employees helped evacuate the patrons, and no one was injured in the blaze, Fox said. A large crowd of onlookers watched the flames engulf the site

while 80 firefighters from eight area companies worked to bring the fire under control.

The building was classified as a total loss, and heavy fire damage was estimated at \$750,000 dollars.

Myers, who lives in southern New Jersey, opened the Middletown franchise in April of 2005, and has owned the Friendly's in People's Plaza since 2002. He also took over ownership of the

Friendly's on Elkton Road in Newark in 2001, but sold the property in 2005 because of lackluster sales, he said.

"Sales were just so-so and I owned the real estate there on Elkton Road, so I sold the property in '05," he said.

He said he was on a plane returning from Charleston, S.C. June 27 when he heard a voicemail that his Middletown restaurant had caught fire and burned to the ground. It was the first time one of his businesses had ever caught fire, he said.

"But the good news is, nobody got hurt," he added.

On Monday, he said he was working with his insurance company and planning to hire a reconstruction team to start planning the site's redesign. He said he would be looking over bids from three different contractors and would soon decide on one to rebuild the structure. Construction should start in the next few weeks, he said.

"Right now, the burned-out frame is still there; because of the investigation, we haven't been able to touch it," he said. "(When the construction is finished,) it will look pretty much the same as it did before, with maybe some upgrades."

He said he was able to employ about half of his 50 Middletown Friendly's employees in other Friendly's stores until the Middletown site is rebuilt. At that point, he said he hopes nearly all of his employees will be able to work for him again in the Middletown store.

Myers said he was grateful for all the support he received from community members after the fire.

"My general manager is always extremely popular in the community - his name is Mike Myers; he's my cousin and he's the general manger - people have been very concerned and showed him a lot of support during this time," Myers said.

Out of the Attic

A milestone of local historical record

This week's Out of the Attic column is the 200th Newark Historical Society column to run in the Newark Post since August of 2008, when the Post's editor invited society members to tell the story of the city's history by spotlighting items in its collections.

The Out of the Attic column dates back to way before that. It started with townspeople submitting pictures and moved through collections, such as the UD Special Collection of post-cards.

This week's picture is a current view of the northwest façade of the historic 1877 Philadelphia, Wilmington, and Baltimore Railroad Newark Passenger Station, which sits trackside, next to the South College Avenue bridge.

Today the station is

the home of the Newark Historical Society, including its collections and the Newark History Museum.

To get there, travel south on South College Avenue, cross Park Place, and as you near the bridge, stay to the right and go down beside the bridge. When you turn left under the bridge you will see the building as it is in this picture. This is the Museum entrance.

The Newark Historical Society was formed in October 1981. Its primary charge is to identify, gather, organize, preserve and share Newark history. During its three decades the society has received many gifts of memorabilia representing the Newark area. These gifts are cataloged and preserved as much as possible. Some items have been loaned to the society.

The Society shares Newark history primarily through the Out of the Attic column and the Newark History Museum. The Museum is open to the public from 2 to 5 p.m. every Sunday, April through November. It is also open at other times throughout the year by appointment; anyone can make an appointment by calling 368-9845.

The Museum also has an exhibit case in the lobby of the Newark Municipal Building and an occasional exhibit in the Newark Free Library. Historical programs are hosted throughout the year. The reference collection includes many back issues of the Newark Post.

Rehoboth, Dewey beaches earn 'superstar' ratings

Rehoboth Beach and Dewey Beach earned national recognition last week as "Superstar" beaches for swimming-water quality.

Rehoboth and Dewey were among 13 beaches out of 3,000 beaches nationwide to earn five-star ratings for perfect swimming-water quality for the past three years. The ratings were published in the Natural Resources Defense Council's report "Testing the Waters," released earlier this month.

This marks the second year in a row that Rehoboth and Dewey Beaches were awarded Superstar status.

In the report, the NRDC had initially awarded Rehoboth Beach a four-star rating, based on the reported frequency of water-quality monitoring. After the report's release, DNREC's Recreational Water Quality Testing Program staff contacted the NRDC with data that all Delaware's ocean beaches were monitored twice weekly. The NRDC later determined

that water-quality monitoring met the frequency criteria and awarded Rehoboth Beach the five-star rating.

Each year, the NRDC evaluates two of the most popular beaches in each state for consideration of the five-star rating. As Delaware's most visited beaches, Rehoboth and Dewey were the only beaches in the state evaluated by the NRDC for Superstar Beach status. The report cited that the Delaware's other Atlantic beaches — Cape Henlopen State Park, Bethany, South Bethany, Delaware Seashore State Park, Fenwick Island, and Fenwick Island State Park — also had perfect swimming water quality in 2011, with no swimming advisories issued.


"With Delaware receiving top honors nationally and both Rehoboth Beach and Dewey Beach being recognized again by NRDC, Delaware is emerging as the most pristine beach destination in the nation," said DNREC Secretary Collin O'Mara.

The NRDC also recognized all of Delaware's beaches with

the highest national ranking for beach-water quality. The state ranked first out of 30 states for the cleanest water quality overall.

ily-owned bike shop, with a 7,400-square-foot location. The store moved in November 2011 from its original location in Newark Shopping Center.

Harvey said the new location at 141 E. Main Street, behind Starbucks, makes the store more visible and recognizable to the university and the community.

"It put us right in the heart of town," he said.

Last December, Wooden Wheels employees started looking into expanding to a second location in Wilmington's Concord Square Shopping Center, on Route 202. After stores there closed, Harvey said Wooden Wheels moved forward with their plans to move into the newly vacant spots.

"Some doors opened up so we decided to pursue that," he said.

The new shop is scheduled to open in mid-July.

Harvey attributes the store's success to its ability to stay on top of trends, offer the latest products, and provide excellent customer service.

The store had a website before most businesses to maintain visibility among bike shoppers, he said. Wooden Wheels stays involved the community by sponsoring and participating in area racing events, he said.

When asked how the store was able to be a successful competitor in the bicycle market for so long, Harvey said, "I think just being passionate about it, reinventing ourselves over the years, and not ever standing still."
