I herewith return without my approval, House Bill No. 16, entitled "AN ACT APPROPRIATING MONEYS FROM THE STATE TREASURY FOR THE PURPOSE OF PAYING THE INTEREST ON CERTAIN HIGHWAY IMPROVEMENT BONDS AND STATE AID BONDS ISSUED BY THE LEVY COURTS OF NEW CASTLE, KENT AND SUSSEX COUNTIES, DURING THE FISCAL BIENNIUM OF THE STATE OF DELAWARE, ENDING JUNE 30, 1945."

While the bill received a unanimous vote in the House of Representatives, it was declared passed in the Senate without having received the vote of three-fourths of all of the members elected thereto. After this bill was presented to me, I received the opinion of the Attorney-at-large to both Houses of the General Assembly, that House Bill No. 16 did not receive in the Senate the three-fourths vote required by Section 4 of Article VIII of the Constitution of the State of Delaware.

Under these circumstances, I cannot give this bill my approval, but this in no sense should be construed to indicate my disapproval of the subject matter contained therein. On the contrary I most strongly urge the passage by both Houses of the General Assembly by the proper constitutional majorities, of a bill containing the substance of House Bill No. 16.
