On June 22, 1970, I received House Bill No. 891 As Amended by House Amendment 1 entitled:

"AN ACT AMENDING TITLE 7, CHAPTER 45, DELAWARE CODE, RELATING TO THE SALE OF PUBLIC LAND"

I am returning the bill without my signature for the following reason:

This bill requires that all leases covering subaqueous lands presently signed by the Water and Air Resources Commission and by me be also approved by the Legislature. Many leases signed cover very small areas so as to allow private individuals to work on private boat piers, to bulkhead to prevent erosion of their land, and other innocuous activities. A number of leases signed in the past year were signed after the Legislature adjourned in June of 1969. To make people wait for six months or more for legislative approval of such leases will create a great and significant inconvenience to many citizens in this State.

I understand that the Legislature is legitimately concerned with the possibility of the construction of some kind of oil loading and off loading facility in the Delaware Bay. I can also understand that the Legislature wants to be involved in the decision as to whether this facility is built at all, and if constructed, where it should be so constructed. However, to include all transactions involving subaqueous lands creates more harm and inconvenience than I am sure was intended. I do not believe the Legislature will relish being re-called in the second half of every year, one or more times, simply to ratify leases of very small parts of subaqueous land.

I would endorse the principle that the Legislature should have an ability to pass, favorably or unfavorably, on a proposed oil loading facility in the Delaware Bay, and if appropriate legislation confined to that would come to my desk, I would sign it.

On July 16, 1970, I received House Bill No. 176, As Amended by House Amendments 1, 2, and 3 entitled:

"AN ACT PROVIDING FOR WARRANTIES IN THE SALE OF DWELLINGS"

I am returning this bill without my signature for the following reasons:

This bill would require the posting of surety by the home builder in the amount of five (5%) per cent of the sale price of the home at the time the Contract of Sale is signed. According to persons in the business of obtaining bonds, it would be difficult if not impossible for home builders to obtain the advance surety required by this bill short of putting up the entire five (5%) per cent in cash. One of the biggest obstacles to house building is the need for "front money" - money for land, design, development, etc. This bill would require approximately an additional One Thousand (\$1,000) Dollars of front money per average size house. The five (5%) per cent surety would equal or exceed the amount of profit in this industry. I am

convinced that if this bill became law many hardworking, honest, small-volume home builders would either go out of business or would have to give up the home construction part of their businesses.

The surety requirement of this bill would add to the cost of the home and would have an adverse affect on an already seriously depressed industry. Instead of aiding the consumer, this increased cost would make it difficult for him to buy a home because housing would become less available and the housing which would be available would cost more than is necessary.

While most home builders are honest and are receptive to complaints made by home owners, there have been some abuses in this industry which need to be rectified. Legislation which would penalize those builders who are guilty of abuses would have my support, but House Bill No. 176 in trying to get at this problem penalizes all builders and all home buyers as well.

I intend to ask the Delaware home builders to consider voluntarily establishing a fund which could be used to pay home buyers, who in the judgment of a review board, have a legitimate claim against a builder.

On July 16, 1970, I received House Bill No. 725 entitled:

"AN ACT TO AMEND TITLE 5A, SECTION 2-201 DELA-WARE CODE, RELATING TO THE REQUIREMENT OF A WRITTEN CONTRACT FOR THE PAYMENT OF A COMMIS-SION FOR THE SALE OR PURCHASE OF REAL ESTATE"

I am returning this bill without my signature for the following reasons:

If this bill became law, it would seriously and adversely affect real estate business. It would create more problems than

it would solve for both buyers and sellers. Some members of the Delaware Bar Association, who are not personally involved in this business and thus should be objective, believe this bill would create much wasteful litigation, thereby contributing unnecessary costs to home buyers and sellers. They report that similar legislation in some other states has caused extensive litigation.

Much business throughout our history has been done by verbal agreement. It seems unwise to outlaw such procedure. People should have access to the courts to settle their disputes. House Bill No. 725 denies the use of the courts to settle a dispute over the payment of a commission for the sale or purchase of real estate unless the transaction involved a written contract.

Even if it were desirable to require written contracts before real estate agents could collect commissions, the present bill as written creates a number of ambiguities and technical defects relative to the Uniform Commercial Code into which it would be inserted.

Furthermore, it appears that if it is desirable to apply the requirements of House Bill No. 725 to real estate agents, then it should also be extended to lawyer, accountants, physicians and others.

Finally, it is difficult to see how a real estate broker who is working to put together a group of properties to satisfy the requirements of a major commercial venture could possibly do his job and live within the requirements of House Bill No. 725.

In summary, this bill would be an unnecessary handicap to the real estate business and would punish many honest people for the abuses of a few. Those who believe they are abused will continue to have recourse to a court which can determine if a commission is payable.

In view of the justifiable concern of the Legislature about abuses in the area toward which this bill is directed, I am asking the Delaware Real Estate Commission to consider what controls might be provided - by legislation or otherwise - to safeguard the participants' interests.
