These changes will ensure that Japanese minors achieve a higher level of proficiency in the language, in line with the minor requirements of other major languages in the Department of Foreign Languages & Literatures. The proposed changes will strengthen the minor by both tightening and raising requirements for it. Students will have to complete more coursework in the Japanese language--a total of 18 credits at the 200 level and above, with 3 credits required at the 400 level. Currently, many students who minor in JAPN do not take a language course at the 400 level, and many students earn the minor by taking only 15 credits (or less) of Japanese language courses above the 100 level because there are several Japan-related courses taught in English (JAPN 204, JAPN 208, and two Japan-related FLL courses) that may count toward the minor.

*Current description of JAPN minor:*

**Japanese:** 18 credits; including 15 credits in JAPN courses at the 200-level or above, with at least 6 of those credits at the 300-level or above, plus 3 credits in a Japan-related FLLT course.

*Revised description of JAPN minor:*

**JAPANESE:** 18 credits in JAPN courses taught in Japanese at the 200 level and above, including 6 credits at the 300 level and 3 credits at the 400 level.

*What changes are being made to the current curriculum:*

(1) The revised version of the Japanese minor requires the completion of one 4XX-level JAPN course. Currently, a 4XX-level JAPN course is not required.

(2) Requiring 3 credits in a related FLL course taught in English is being deleted.
