At the presnet time there are nearly 100,000 of our citizens who have enlisted in some phase of Civilian Defense activity.

There are 61 Local Councils that have been organized and are operating in the State—26 in Wilmington and New Castle County, 14 in Kent County and 21 in Sussex County.

Thousands of our citizens to be enabled to render experienced service in an emergency, should it arise, have, at their own expense and on their own time, prepared themselves by taking courses in First Aid, Chemical Warfare, Motor Corp Drivers, Nurses Aides, etc.

The Problem

Preparation for our national defense requires cooperative effort with unity of purpose throughout the country. The nation must have strong military and naval forces, adequately trained and equipped; it must assure the economic, physical and social fitness of the people as a whole; it must refresh and make more firm their loyalty to the national interest by affording opportunity for officials and citizens alike to gain a clear understanding of programs and objectives and give fruitful expression to their desire to serve. Fortunately, a vast network of organized effort, both public and private, has been enlisted to achieve these ends.

AGRICULTURAL RESOURCES AND PRODUCTION COMMITTEE

DR. GEORGE LEE SCHUSTER, Chairman

FUNCTION: Includes the conservation and use of land and the crops and livestock it supports; and the growing, marketing and processing of plant and animal products for consumption as food or as raw materials entering into industrial production.

To develop a program for the amplification of essential crops that might be necessary under present or anticipated emergency conditions. To provide for suitable protection of nonessential but economically desirable crops. To study, in cooperation with the War Department and the United States Departments of Commerce and Agriculture, the possible development of essential critical materials.

Report

"The agricultural production of Delaware reached an alltime peak during 1942. The tremendous production of poultry, eggs, milk, hogs, soybeans, truck crops, fruit and home vegetable gardens was achieved in spite of serious shortages of labor and materials. Naturally the favorable weather conditions were extremely important. Even with favorable weather the farmers and their families who labored long hours in the fields deserve special recognition for a difficult and vital job well done.

B. Victory Garden Program

With the cooperation of all agencies outstanding progress was made in the number of family gardens throughout the state. The Extension Service cooperated with the Defense Council and Agricultural agencies in supplying subject matter information and specialist assistance. More than 5,000 copies of the Delaware garden bulletins were distributed and five timely printed subject matter service letters were sent to more than 3,000 families per issue. The 1,700 home demonstration club members reported canning and storing the following quantities of meats, vegetables and fruits:

There were 273 4-H Club members completing garden projects with a total of 211 acres. From these gardens the club members canned 13,359 quarts of vegetables.

C. Farm Scrap Harvest

All organizations in the State cooperated in the Farm Scrap Harvest. As a result of the collection campaign more than 9,000 tons of scrap metal were secured from the farms of the State. The 4-H clubs report the collection of 252.5 tons metal, 67 tons rubber and 27 tons paper.

D. Fire Prevention

Due to the increased danger of farm fires and resulting loss of critical crops and material, special emphasis was placed on this phase of the work. A wartime Extension folder entitled "Prevent Farm Fires" was prepared, printed and sent to each farm family of the State.

Through the press and radio farmers were advised to reduce fire hazards by taking an inventory of existing hazards and then eliminating them. They were also asked to check on availability of fire-fighting equipment on the farm. The publication provided a convenient list to be used in taking this inventory.

E. Neighborhood Leadership Program

(Extension Service Volunteers)

Rapid changes in the agricultural situation as a result of war and the need for increased food and feed in the face of labor and material shortages made it necessary to develop a means of rapid and personal communication. With the cooperation of OCD officials each county was divided into communities with a community leader. Each community was sub-divided into a neighborhood consisting of from 10 to 30 families with a neighborhood leader. It is the responsibility of the Extension Service to keep all community and neighborhood leaders supplied with authentic and timely information on all matters pertaining to agriculture. This information will include rationing, priorities, blackouts, production goals, etc. In case of real emergency, it is possible to inform every farm family within 24 hours.

F. Labor

The critical shortage of labor in 1942 has made maximum production very difficult. Through the cooperation of the Governor and farm leaders of the State, a migratory labor camp was secured and located at Woodside, Delaware. Although this camp never operated at capacity, 4,780 man-days of labor were furnished farmers in that area.

Through the efforts of the Vocational Agriculture Departments, a corps of high school boys were enlisted to assist in relieving the labor shortage. Six hundred fifty-six individuals volunteered and 281 were placed. Of those placed, 135 were employed on farms, 66 in canneries and 80 in other forms of temporary employment. Although this group of volunteers was used to a limited extent, much credit goes to the Vocational Agricultural Departments for their assistance.

In addition, the Farm Placement Service of the United States Employment Service had a farm placement man in each county. These men assisted farmers in securing labor. The Farm Placement Service faced many difficulties in finding enough satisfactory replacements to supply the demand.

According to a recent survey of 779 farmers in the State, 6.9 per cent of the farm labor was lost to the armed forces while 13.3 per cent went into industry.

G. Investments in War Stamps and Bonds

The Associate Director of Extension served as chairman of the State Agricultural Committee on the War Savings Staff. County committees of agricultural leaders were appointed in each county to assist the county War Savings Staff chairman in promoting the sale of war stamps and bonds to farmers. Due to the miscellaneous sources of farm income, it is impossible to report specific data on total investments in stamps and bonds by farmers of the State. It is, however, safe to say that a very high percentage of farmers are making regular purchases of stamps and bonds as an investment to use in the post-war period of re-adjustment.

III. AGRICULTURAL OUTLOOK FOR 1943

Farm people of Delaware and the nation will face the necessity of maintaining an even increasing in the production of food products in 1943 under very unfavorable and challenging circumstances. Labor will be reduced, ceilings will be placed on farm commodities, farm machinery rationed, new machinery production will not be more than 24 per cent of 1940 production as compared to 80 per cent in 1941, farm trucks will be limited in capacity load and mileage, supplies of chemical nitrogen in fertilizer limited, and general ration of commonly called production essentials. Even in face of these difficulties, the Delaware farmer can and will produce to the limit of his capacity and facilities available. He has been and will continue to be one of the most dependable patriots of the nation.

CIVIL PROTECTION COMMITTEE

ANDREW J. KAVANAUGH, Chairman

FUNCTION: Includes the protection of civil liberties, maintenance of law and order, and measures to guard against sabotage and subversive activities, by the legally constituted authorities through the enforcement of law and the exercise of regular and duly established police powers.

Dealing with protective and preventative measures and policies relating to properties essential to national defense; law enforcement problems of national defense; cooperation with Federal, State and local officials in matters relating to espionage, sabotage, violations of neutrality regulations, sedition, propaganda, mob violence, violations of civil liberties, interference generally with effective operation of law enforcement and National Defense program.

Report

"At the present time there are 21 paid State Police Departments in the State with a total personnel of 369 men. These departments have organized and trained 2,158 Auxiliary Policemen in the three counties as follows: New Castle County, 1,452; Kent County, 275; Sussex County, 431, making a total of 2,158 trained Auxiliary Policemen in the State.

"There are 47 Volunteer Fire Companies and one paid Fire Department in the State with a total personnel of 1,933. These fire companies have organized and trained 905 Auxiliary Firemen in the three counties as follows: New Castle County, 677; Kent County, 28; Sussex County, 200, making a total of 905 Auxiliary Firemen in the State.

"In addition to the above specified number of Auxiliary Firemen and Policemen, we have trained, at the request of various manufacturers, owners of public buildings and stores, approximately 200 Auxiliary Policemen and 400 Auxiliary Firemen."

EMERGENCY MEDICAL SERVICE COMMITTEE

DR. MEREDITH I. SAMUEL, Chairman

FUNCTION: Cooperate with medical, relief and other agencies in surveying hospital facilities . . . emergency and regular . . . and creation of relations to render possible immediate concentration and utilization of medical supplies and facilities. To emphasize importance of maintaining and improving standards of health and welfare as aid to defense. To direct activities concerned with nutrition problems.

Emergency Medical Field Units:

Emergency Medical Field Units, each one consisting of one doctor and one nurse are attached to hospitals and proceed to the scene of an incident only on advice from the Control Center.

Ambulance Service in Wilmington:

We have 24 ambulances and they are driven by members of the Red Cross Motor Corps and are under the direction of the Chief of the Emergency Medical Service.

In the Counties there are three ambulances attached to each Casualty Station and 2 ambulances at each Control Center.

Training:

All members of the Emergency Medical Service have periodic drills to perfect them in their duties in case of an actual emergency.

Canteen Service:

Canteen Service is rendered by the Red Cross under the direction of Chief of Emergency Medical Service.

Equipment and Supplies:

Equipment and supplies have been allocated for the State of Delaware by the Federal Government, but to date no supplies or equipment have been received by the Property Officr.

Injuries to Civilian Defense Workers-

Medical and Cash Benefits:

There has been established by OCD medical care and benefits due to death or injuries sustained by Civilian Defense workers including members of or trainees for the Protective Service of the United States Citizens Defense Corps as well as members of the Civil Air Patrol and Aircraft Warning Service.

HOUSING, WORKS AND FACILITIES COMMITTEE

EMMETT S. HICKMAN, Chairman

FUNCTION: To provide temporary housing in the event of evacuation of areas.

Includes provision of housing, particularly for people of low income and for Army and Navy personnel; buildings and structures; works for water supply and sanitation; power production and transmission; highways, airports and other transportation facilities.

To survey existing housing facilities and recommend on any planning of defense housing programs. To coordinate these activities of Federal agencies in order to insure an effective and integrated program. To anticipate housing needs and take steps to avoid housing shortages. To determine whether the construction of additional housing facilities should be undertaken by private enterprise or by public agencies.

Report

"During the term which this committee has been appointed, we have solicited 141 locations and have secured the signature of the owners for 43 properties. These properties will accommodate 7,020 persons. Some of these spaces can be used for all year round services, others only in the summer time.

"Thirty-one properties, rated A-1 to C, will accommodate 4,065 persons. Several of the properties inspected and offered to the committee were located in the zone between State Road, Claymont, Delaware River and Faulk Road. As those properties are in the firing zone set by the War Department, we did not take any of them, but suggested that they could be used by local defense councils for neighborhood use.

"Meetings have been held by the regular committee throughout the year and by the sub-committees, which actually inspects
the properties, signs up the owners and solicits properties in
general. Almost daily, throughout the term, Mr. Tindall's committee of architects, and Mr. Tindall personally in most cases,
has inspected every one of these locations and issued a card
showing the exact use to which the property can be made, the
number of persons to be accommodated, facilities for sleeping
and feeding. This has entailed a tremendous amount of detail
work. A sample of the card used is enclosed and copies of these
cards are in the hands of Mr. Koester of the City of Wilmington,
Red Cross, Mr. Tindall, Miss Mullin of Registration, Mrs. Funk
of Canteen, and my office. Lists of these locations are in the
hands of the Committee.

"In the test cases of evacuation, we have arranged to have one of our committee members on the ground of the evacuation center and they have stayed throughout the entire period when test evacuees are on or near the premises to which they were allocated.

"Mr. Tindall of this committee attended a meeting in New York for several days in the early part of the year, concerning air raid shelters and evacuation.

"After an investigation of the central part of Wilmington, we believe that there is very little opportunity of shelters, except in some of the large office buildings, and therefore, on April 28, 1942, we addressed a letter to Mayor Albert James of the City of Wilmington suggesting that preliminary plans be drawn for the erection of such shelters, in the event that they would be needed later, our thought being that it would be proper to have these preliminary drawings completed and a list of the materials arranged so that if, as, and when we had to go into such a venture, we would have that much of the detailed work completed. We likewise, submitted this list of proposed locations to Mayor James. This covered the central part of the City and 31 sites.

"Mr. G. Leslie Gooden, who is chairman for Kent County on this Committee, reports that the Town Chairmen were called together at Dover on Tuesday, July 14th, 1942, at which time the problem of housing in that community was discussed. The

meeting was well attended and it is reported that considerable work has been done for housing evacuees and a large number of private homes have been offered, as well as public and semi-public buildings.

"Mr. Elbert N. Carvel, who is chairman for Sussex County on this Committee, reports as follows:

- "The main object of the Housing Committee for Sussex County was to provide temporariy housing for evacuees from the coast of Delaware in case of invasion or enemy action against the coast. Toward that end I have appointed Housing Chairmen in Laurel, Seaford and Bridgeville. I have been unable to receive any cooperation from Greenwood as yet but I will make an effort between now and December 15th to have a chairman appointed there.
- "Chairman C. E. Anderson of Bridgeville has made a complete survey of the housing facilities available and I have a card system of the names and addresses for that area together with the number of people who can be accommodated. Chairman Truitt Tull of Seaford has likewise made a survey of his area and I have a file of cards of the facilities available in that section.
- "'Chairman Howard Elliott of Laurel has completed about 80% of his survey and we have cards for the housing facilities available in this area and I assure you that this survey will be complete by December 15th. After this program becomes complete, I will be glad to write your further.'"

HUMAN RESOURCES AND SKILLS COMMITTEE

RAY W. HEIM, Chairman

FUNCTION: Includes all activities relating to the supply of, and demand for, human energy, professional scientific or technical competence, trade and occupation skill, and the training and rehabilitation necessary to supply, present or anticipated needs.

Report

"Since July, 1940, public vocational schools have been supporting and conducting training programs to bulwark first the national defense program, and now the nation's war production training program. This nation-wide emergency vocational training has been made possible through the expansion of a well established vocational program developed since the last World War. When the call came for trained men for defense industries, the Delaware Schools were ready with a nucleus of experienced instructors and modern equipment.

"The tremendous demand for war production training in the past year has occupied the waking hours of many Delaware school administrators, vocational teachers, and supervisors. Closely cooperating with them have been numerous Delaware organizations representing education, industry, labor, and government. The record to date indicates that this cooperation has brought tangible results; and the contributions made by these schools to the lives of the men and women trained, to the personnel needs of American industry, to good citizenship, and thus to American democracy, are significant.

"However, the vocational training facilities in the public schools were soon over-taxed. Additional quarters were secured. and schools have sent into the industries skilled instructors to carry on training and upgrading workers on the job. In the beginning, trainees were recruited from the ranks of the unemployed, and later from peace-time occupations where their services were no longer needed. Training has been conducted in 12 rural communities, and in Wilmington. There have been over 13,000 men and women enrolled in emergency training, and the numbers are increasing daily due to the expansion of industry and the need for training. Classes are conducted in Aircraft Riveting, Assembly, Welding, Blueprint Reading, Ship-Welding, Shipfitting, Carpentry, Sheet Metal, Plumbing and Pipefitting, Electrical, Machine Shop, Marine Machinist, Arc and Gas Cutting, Radio and Communication, Foremanship Training, Auto Mechanics, Metalwork, Electricity, Woodwork, Farm Machinery Repair, and Auxiliary Instruction. In all of these occupations, men and women are being trained for instructors and for employment. The entire cost of this training program is borne by the Federal Government.

"All of this emergency program has been carried on in addition to the regular program, where nearly 8,000 trainees were given vocational training during the past year in the fields of agriculture, homemaking, distributive occupations, trades and industries, and rehabilitation. These people are all potential workers for employment in the war effort."

INDUSTRIAL RESOURCES AND PRODUCTION COMMITTEE

J. WARREN MARSHALL, Chairman

FUNCTIONS Includes the extraction and processing of minerals, petroleum and other non-agricultural raw materials; manufacturing operations; the development and organization of the necessary facilities for such processing and manufacture, and of power, transportation and distribution facilities incident thereto.

To cooperate with the procurement and procurement planning divisions of Army and Navy and with industrial management to effect the greatest possible utilization of suitable local industrial facilities for the production of essential defense materials. Elimination of bottlenecks in industry. Analysis of plans for the procurement and expediting the development of strategic and critical materials.

Report

"This Committee has given constant and careful attention to the expanding production of war materials in Delaware.

"At the present time, there are 90 establishments in the State engaged in war production. Many of these companies have successfully gone through the period of change-over from civilian production during the past year.

"Increased production with its corresponding requirement for additional workers, has created a serious labor condition in this area. In an effort to relieve this situation, the Committee has encouraged the Training-Within-Industry Program of the War Manpower Commission and voluntary action of manufacturers to eilminate unnecessary movement of workers from one war plant to another.

"Meeting of representatives of manufacturers have been held to discuss the disastrous effect of labor piracy and to take the necessary action to put into effect at each plant the policy of the War Department to eliminate such piracy.

"In the collection of salvage, Delaware stands fourth among the States, in proportion to population. The Industrial Salvage Campaign is organized and from the reports received, it is highly successful.

"The tremendous influx of workers makes the housing situation serious. A large number of additional housing units are required and every effort has been made to supply this housing but, because of inability to secure priority ratings, this matter is not progressing as satisfactorily as might be wished.

"The Delaware Office of the War Production Board is well organized and is cooperating with our producers in securing war contracts and the necessary materials for manufacture.

"In this, our first year of full war activity, the necessary organization changes have been made and it is expected that the continual growth and expansion of war production in the coming year will be accomplished in an orderly manner."

PRESS AND PUBLIC RELATIONS COMMITTEE

HENRY T. CLAUS, Chairman

FUNCTION: To counsel with the Executive Committee on all phases of publicity and public relations. To provide adequate means for the placement of essential publicity. To assist in adding to clear thinking and understanding on the part of the public.

Report

"It has been the special duty of the Committee on Press and Public Relations to give the people full information about the activities of the State Council of Defense, the regulations promulgated by the Council and the opportunities open to them for service and cooperation. In pursuit of this duty the Committee has had the helpful and whole-hearted support of available agencies—the daily, Sunday and weekly newspapers, the radio, the moving picture theatres and the outdoor advertising companies. In one way or another the necessary information must have reached every citizen of the State."

FINANCE COMMITTEE

HENRY T. BUSH, Chairman

FUNCTION: To cooperate with the Industrial Mobilization Group so that convenient channels may be established for the provision of fixed and working capital that may be required as an essential incident to defense production. To undertake preliminary investigations of expansions and other capital requirements to assist in determining their necessity and practicability. To assist the government authorities in publicizing and marketing defense or war bond issues of liberty bond character that may be developed for sales to the public.

Report

"The committee has cooperated with the Treasury Department Officials and Committee in organization throughout the State for the sale of war bonds and stamps.

"State financial institutions have cooperated by providing capital to plants undertaking war contracts."

LABOR COMMITTEE

JOHN J. HARTNETT, Chairman

FUNCTION: To cooperate with employers, representatives of employees and of governmental agencies in an amplified apprentice and vocational training program to expand our present limited supply of skilled craftsmen whose services will be essential in the present and possible extended emergency. To develop and conduct an effective plan looking toward the distribution of our present limited supply of skilled craftsmen on the general basis of productive need and designed to prevent improper bidding for skilled services. To coordinate employment policies in industries involved in National Defense.

Report

"Your committee as a group and individuals, have cooperated with various industries in the recruitment of forces to produce war contracts and has cooperated with Apprentice and Vocational programs, both in the plants and schools."

Transportation and Communication Committee

WILLIAM A. SIMONTON, Chairman

also War Administration Administrator

FUNCTION: Through liaison facilities with Army and Navy to forecast the extent of military use of transportation and communication facilities in possible future emergencies. To thoroughly survey existing facilities in water, rail, highway and air transportation, and in radio, telegraph, telephone communications. To develop plans for relative uses of these facilities by industry and the public in coordination with the military use. To develop plans for the amplification of present facilities should such expansion seem warranted to protect the probable requirements of future emergencies.

Report

Staggering of Working Hours:

"Prior to appointment as War Transportation Chairman, the Chamber of Commerce, Delaware, appointed a Committee to make a study of the rider habits of workers using the mass transportation system of Wilmington, Delaware. Your chairman was Chairman of the Committee on Staggering of Working Hours and subsequent to my appointment as War Transportation Chairman, administered the operation of the staggered hours study in that capacity. The survey was made in cooperation with the Office of Defense Transportation for the purpose of conserving vital war transportation facilities, and the Committee appointed by President Hickman of the Chamber of Commerce, Delaware, represented manufacturers, mercantile interests, employers of large groups of employees located in the central business district, representatives of rail lines, bus companies and State and City officials.

"This survey also included the public school children in Wilmington and vicinity who were users of the local mass transportation system.

"With the vast number of war workers locating in Wilmington and vicinity together with the inauguration of gasoline rationing, the inability of great numbers of users of personal transpor-

tation to obtain tires, complicated further by the lack of being able to secure additional buses and trolley coaches, the situation confronting the operators of our local mass transportation system became an acute problem in the Spring of this year.

"The Gommittee appointed by President Hickman conducted a survey of the rider habits of 50,000 workers, school children, and employees of the public school system. As a result of this study, recommendations were made to various industrial plants and employers of large groups of employees located in the central business area, suggesting changes in working hours to relieve the peak loads in the A. M. and the P. M. periods.

"The recommended changes were put in effect over a period extending from July to September. The Committee also recommended that the store hours be changed to take effect in September. This program has been adopted.

"As a result of the changes in the working hours, a survey conducted in October, 1942, shows that there was a net improvement of 20% in the morning rush hours and 16% improvement in the afternoon peak hours.

Group Riding:

"Through the cooperation of the Office of Price Administration, the Highway Traffic Advisory Committee, and the War Transportation Committee, all plants in the State of Delaware having twenty or more employees have been contacted to join in the Group Riding Campaign, the purpose of which was to conserve the use of the private automobile by utilization of its full carrying capacity.

"The Office of Price Administration handled those plants working on defense projects and employing one hundred or more. The Highway Traffic Advisory Committee covered all plants in Kent and Sussex Counties regardless of the type of employment and the War Transportation Committee covered all plants in Wilmington and New Castle County employing over twenty persons excepting those war plants that were covered by the Office of Price Administration.

"To assist the workers in forming the Group Riding, maps were prepared together with appropriate cards giving full information as to the address of the car owner and the number of passengers that it was possible to carry. The maps were blocked in Sections and numbered and with this reference, it was possible to form the groups in a uniform manner.

"A recent survey of representative plants in Wilmington and New Castle County show that the private automobiles used in transporting workers is being utilized to over four persons per car on the average."

DISASTER, EMERGENCY AND EVACUATION COMMITTEE

R. R. M. CARPENTER, Chairman

Report

"One complete evacuation practice was carried out by having instances reported to the Control Room by Block Wardens. With the cooperation of the Transportation Committee, the Housing Committee, and the Red Cross, as evacuation was made from the selected locations to evacuation centers. The drills were satisfactorily carried out.

"The Red Cross Chapter invited a representative of the North Atlantic Area of the American Red Cross to come to Wilmington and speak on the question of disaster, emergency and evacuation. This representative had spent some time in England and was thoroughly familiar with what had been done there. Members of the State Committee were invited and several attended. He stressed the fact that the chance of a bombing on the east coast of the United States was rather remote, but that preparations should be made for such an event should it ever occur. He went into considerable detail and I think that his visit to Wilmington was warranted and that we all received considerable information of value.

"It is my feeling that we are sufficiently organized to carry out an evacuation, should one be necessary."

AIRCRAFT WARNING SERVICE COMMITTEE

GEORGE EHINGER, Chairman

Report

"The organization of the Aircraft Warning Service in Delaware was carried out under the direction of the United States Army Air Force and completed early in July 1941. The first state to be one hundred per cent organized. Less than twenty-four hours after Pearl Harbor was attacked, the entire Air Spotting organization, consisting of sixty-nine posts, swung into action on a twenty-four hour a day basis. The number of Observers now serving in this organization is approximately eight thousand.

"It is a tribute to the personnel of the various Observation Posts that this entire service was established and the equipment provided through the efforts of the Spotters themselves and the communities adjacent to the Observation Posts. Ten thousand dollars has been raised and spent on the building of Observation Post shelters. The installation and rental costs of telephones, as well as heating equipment and fuel, have been provided by the Spotters and nearby communities. Without this initiative, the Aircraft Warning Service would never have functioned effectively.

"The personnel of each Observation Post is under the direction of a Chief Observer and the State is divided into fourteen districts, each with a District Director having supervision over certain designated Posts. In charge of the entire State is the State Civil Director who receives his instructions from the First Fighter Command, United States Army Air Force.

"In addition, the Aircraft Warning Service is responsible for the establishment and operation of the three Warning District Centers of the State located in Wilmington, Dover and Georgetown. These are manned constantly on a twenty-four hour a day basis by a personnel of approximately nine hundred fifty volunteers. These three centers relay to ninety Community Control Centers, vital defense organizations, and military establishments, all warning messages that must be transmitted for the public safety. Without these three Warning District Centers, all civilian defense services would be helpless in the face of an enemy attack since there would be no organized way of notifying our communities of the approach of an enemy.

"Furthermore, back of the Warning District Centers must be the Observation Posts which secure the information upon which the warning messages are based. It is therefore obvious that every effort must be made to maintain the operation of our Observation Posts at as high a level of efficiency as possible if our entire civilian defense setup is to function effectively and if the Air Force is to receive the information necessary to carry out their job of interception."

Women's Division Committee

MRS. C. M. DILLON, Chairman

Report

"Immediately after the declaration of war December 8, it was decided to open an office for the registration of civilian volunteers for Civilian Defense, and such an office was established in the Municipal Building in Wilmington under the direction of your chairman, who immediately organized a volunteer staff of

ninety women, who served regularly each morning and afternoon. Personnel was supplied for instructional classes in various curricula necessary to intelligent prosecution of defense operation. Traveling groups were organized to visit various plants and training classes. This registration office was operated for two months, volunteer women conducting the registrations by day, and a group of Past Commanders of the American Legion were in charge during the evening. More than 12,000 volunteers were registered. Under direction of your Chairman, similar offices for registration were opened in Newark, New Castle, Dover, Milford and Seaford.

"A carefully-selected group of twenty women were secured for service as an Executive Committee of the Women's Division. The members of this Committee were chosen for their knowledge and experience in the various lines which would be required in defense work, each representing an organized group of women, with the ultimate purpose of service as liaison duty in transmitting to their various groups such information and instructions as were necessary or desirable, and, through them and their organizations, transmit that data throughout all sections of the State, preparing and guiding all activity phases of the program, and receiving and handling calls for information and assistance in various localities. This group included the Presidents and Chairmen of Wartime Activities of the following groups:

American Women's Voluntary Service,

Society of Colonial Dames,

State Congress of Parents and Teachers,

State Chairman, Women's Committee for Salvage, State Chairman, Women's Division, War Savings Committee, State Chairman, Victory Gardens.

"In December, 1941, representatives from the New York Headquarters of this organization visited this city with a view to organization of a branch here. After many conferences with coordinators and Civilian Defense representatives, this was established and offices opened January 16, 1942, with Mrs. George L. Callery in charge, with a daily staff of twenty women. The roster now contains more than 2,000 women volunteers. It is supported by private subscription.

"Mrs. William H. Dutton was appointed Chairman of Victory Gardens, with a managing committee of ninety volunteers. Full-time service has been given to cooperation with all services necessary to a united front. This Committee reports the establishment and operation of 5,000 gardens throughout the State.

"Delaware was the first State in the Union to establish food banks as an activity of this Committee, the work of which is very modestly mentioned in the report of Mrs. Dutton.

"Women's Cooperation Councils through the State report close cooperation with the men. Your Chairman can only report by observation and comparison. Between 35,000 and 40,000 women in Delaware are engaged in some special war activity.

"Although the matter of Air Raid Spotters is not included in the Civilian Defense program, this office has assisted by recruitment, and now finds is necessary again to help secure workers in this important service.

"Approximately 500 women are on duty in the various control rooms. The Supervisors plan the study and instruction, and bring to their groups information to sustain interest. They also arrange for "incidents" to be reported for practice, and members of the crews trained in proper recording.

"At a recent conference with Chief Air Raid Warden A. J. Kavanaugh, plans were made for organization of a system of fire watchers for the City of Wilmington. Time alone will tell the results of this plan.

"The organization of the Women's Committee heads a State volunteer service easily reached and, so far, more than willing to serve the State and its people. Under this system the work progresses. A program presented by a Regional Office easily may be arranged by key women in each town, the State Chairman directing. Any other plan causes "too many fingers in the pie," and upsets an otherwise fine set-up.

"With a small population, it is necessary to arrange that the same groups are not used repeatedly or exclusively. There has been but one point of contact between State and Regional Office. This centralization must be recognized, or our entire volunteer plan will be disrupted. Right now the program along all lines is suffering; men are leaving for the armed services; both men and women are accepting employment in defense plants, and the ever-increasing shortage of servants and domestic help all tend to keep those who have so faithfully acted, at home.

"In July the Executive Order coming through providing that Civilian Defense furnish volunteers for OPA resulted in the organization of a group of 250 women for "Price Posting Day"—all rationing boards—with no exceptions—have groups of OCD volunteers registering at their offices and, after instruction, completing application forms for applicants. Of these, there are nearly 500 in the State. All volunteer groups, of necessity, face changes of personnel, a complete change being necessary many times.

"The Women's Division sponsored the opening of the first booth for the sale of war stamps and bonds, the revolving fund necessary having been furnished by Mrs. S. M. Dillon, Mrs. Graselli, Col. Charles H. Gant, and the Delaware Citizens Association. This booth now has been transferred to the jurisdiction of the War Savings Committee under Mrs. S. M. Dillon as Chairman of Booths.

"The Executive Committee has had the leaders of every part of the program as guest-speakers at its various meetings, and this has been a power of good for encouragement and stimulation, of cooperation in all phases of war work in each community. It also has aided materially in distribution of work and equalization of effort.

"It is felt that it is most important that work be centralized, and given out with some sense of equal division. Volunteer work in Delaware has been an example due absolutely to the willingness of our women to serve their State, and the firm belief that in this service we may keep Delaware at least a semblance of home in the minds of those who will return from the battle line.

"Your Chairman's personal activities, other than instruction and directional leadership, include monthly visits to C. D. division; the compilation and broadcasting of six scripts of Civilian Defense and war activities; addressing more than 20 meetings in various sections of the State; conducting more than 200 conferences with leaders and chairmen in all women's activities throughout the State; encouraging and giving aid where

necessity arose; this end of her work requiring fifteen trips to various cities and towns. More than 2,000 necessary telephone calls were made, and contacts innumerable with Regional Offices and representatives."

STATE DIRECTOR O. P. A.

JAMES L. LUKE, JR.

Report

Resume of the Rationing Program in Delaware:

"The rationing program began in Delaware on December 26, 1941, when the Office of Civilian Defense was asked to set up rationing boards in each community in the State where a Civilian Defense unit had been organized. On that same date, Mr. Gassaway, Executive Vice-Chairman, State-Council of Defense, appointed the writer as State Rationing Administrator, to assume the responsibility of this task. At that time there was established 53 boards, comprising three members each; a County Administrator for each county was also appointed. The three appointed were at that time serving as County Coordinators of Civilian Defense. The membership of the boards was recruited through the OCD. This arrangement was in compliance with a direct Executive Order from the President of the United States, and applies throughout the nation.

"Due to the amount of letter-writing and mimeographed instructions necessary to be sent out, and the lack of funds available for clerical help, it was necessary to reduce the number of boards. This was done by combining certain boards with others, bringing the total down to 33. With the aid of the clerical staff of the State Tax Office, who volunteered so generously, the work of rationing in Delaware began to flow smoothly. As the work increases, funds were made available for the employment of clerical help, but not in sufficient amount to completely staff 33 boards. It again became necessary to reduce the number by combining several into one, with the result that throughout the State of Delaware, 11 boards were established and are now functioning as the present War Price and Rationing Boards, with four located in New Castle County, three in Kent, and four in Sussex. The County administrators were eliminated, with one State Rationing Officer assuming their duties; a State Office was established, and the former State Rationing Administrator appointed as State Director, guiding the boards in all forms of the program.

"The first articles to be rationed were tires and tubes, necessitated by the serious shortage of rubber importation. In line has followed, as vital products were necessary for the war effort,

the rationing of automobiles, typewriters, sugar, gasoline, bicycles, rubber footwear, fuel oil, coffee, and very shortly to be rationed, stoves. As the program increased the main boards were requested to appoint panels to ration the different commodities. Also appointed were field representatives, residing in those districts away from the board locations, so that applicants might be assisted in filling out the various forms and having them forwarded to the boards for action, without hardship, by means of travel, etc., to the applicant.

"The personnel for the panels and representatives were all drawn from the OCD. With this increased activity, clerical volunteers were also recruited in the same manner. Today, serving wholeheartedly and generously as to time, the OPA in Delaware has some 430 members (all volunteers) on the various boards, panels and as field representatives, together with an approximate personnel of 400 volunteer clerical assistants, upon whom the boards constantly rely to aid them in the various duties of rationing.

"Confronting us now is the issuance of War Ration Book II, which will be used to secure goods that will be rationed under a new system known as the "point system." It will not replace straight coupon rationing, but will be used for certain new rationing programs. Everyone who has War Ration Book I is eligible for Book II.

"American armed forces fight on more and more battle fronts in continually increasing numbers. Our fighting forces and our Allies must be sent more and more supplies, food and ammunition. We must get along on less—if there is not enough for both civilians and the armed forces. Where there is a shortage of essential commodities for civilians, what we have must be distributed fairly to all. May I take this opportunity to explain how our coupons, issued to the consumer, must flow upstream through the retailer, wholesaler, supplier and manufacturer? Upon receipt of the coupons from the consumer, the retailer, wholesaler, etc., acquires his amount of rationed commodities which flow back into the State of Delaware for a fair distribution to all, which keeps the supply in Delaware adequate for our essential needs. This will also apply to the point system of rationing.

"That is why we ration in these United States—to provide those who are fighting and dying for us, with everything they must have to win; and to assure each of us at home his fair share.

"The task is tremendous and to successfully "Carry On" we must depend upon the volunteers. Our whole program would be a practical impossibility without their help. Our thanks is extended to the OCD for its help and support in our work."

CIVIL AIR PATROL COMMITTEE

MAJOR HERMAN MILLER, Wing Commander

Report

"The Civil Air Patrol is not now engaged in any flying activities.

"We are in the process of completing all our Training Directives.

"Our total personnel to date, including commissioned officers, non-commissioned officers and enlisted members is 210. These include the Wing Staff, the Group Commander, the Squadron Commander and Staff and enlisted personnel."

STATE PROPERTY OFFICER

COL. E. S. STAYER

Report

"Advices from the State Council of Defense are to the effect that property allocations will be made to the following communities:

DIM-OUT COMMITTEE

JUDGE JOHN P. LEFEVRE, Chairman

Report

"I am pleased to submit a report as to the compliance in the dim-out area of Delaware with the regulations controlling the use of artificial lighting in our two lower counties, as promulgated by the Commanding General of the Second Service Command.

"The regulations were published to the municipal authorities of each of our towns, and were spread by our State Police and the local police authorities, and further published in the local papers. I am pleased to report that the authorities have cooperated in every instance to the extent of their ability, and frequent inspections of the area satisfy me that every community and most individual locations, are now dimmed out to the satisfaction of the military command. This result was obtained largely because of the splendid assistance of the State Police who have been untiring in their efforts to secure this result.

"It is hoped that full compliance with the regulations can be secured without resorting to the imposition of legal penalties on any of our citizens."

FOREST FIRE FIGHTER SERVICE COMMITTEE

W. S. TABER, Coordinator

Report

"The Washington Office of the OCD, pursuant to Administrative Order No. 27, requested the State Council to nominate a person as State Coordinator of the OCD Forest Fire Fighter Service.

"My appointment by the State Council was followed by appointment by David P. Godwin, National Coordinator FFFS.

The Proposed Delaware Plan:

"Certain basic principles of Forest Fire Fighters Service are apparent. They may be listed as follows:

- 1. The FFFS is one of several OCD programs stemming from the Facility Security Administration.
- 2. The FFFS is designed to function as an adjunct to or auxiliary to the established forest protection agency within the State.
- 3. Inasmuch as OCD is characterized throughout by voluntary service, this principle will be adhered to in the FFFS set-up.
- 4. The identical pattern of OCD recruitment and organization should be followed in the Forest Fire Fighters Service.

"Plans for development of the recruitment part of the program consist of:

- 1. An appointment of County Coordinators. These in most cases should be the present County Coordinator OCD.
- 2. The appointment of Local Coordinators. In many cases it will be found that Local Coordinators of other OCD projects can also take on the recruiting of FFFS members, but where suitable personnel is not available a Forest Fire Warden or registered forest fire crew member should have preference.
- 3. Teaching and training plans will have to be formulated on the basis of enrollment and other factors. Plans for the groups will likely have to be planned individually.
- 4. Whether a teaching manual is printed depends on (a) the indicated need for such, and (b) allotment of funds therefor. Such a manual would undoubtedly pay for itself in teaching time and travel expense. Wherever possible, professional teachers will be enlisted for teaching. The Forestry Department fire control personnel will in most cases assist the teachers in carrying on the training exercises.
- 5. Supplying certified members of the FFFS with fire fighting tools and equipment is not contemplated. We would not have enough tools, nor do we have the funds to buy such. As an alternative and perhaps the better plan, the instructions will stress the use of such hand tools as are ordinarily a part of every household or farm. Such as rakes, shovels, forks, brooms, buckets, and burlap bags, hand axes, and a good jackknife to cut a forked stick or pine bough.

6. Heavy duty forest fire fighting equipment is housed at the Headquarters of the Redden State Forest and a 250-man cache of tools is being built up there. This constitutes a reserve for extreme emergencies. When the need arises for items of this reserve it will be manned by skeleton crews of regular forest fire control personnel supported by auxiliary forces of FFFS."

VICTORY GARDEN COMMITTEE

MRS. WILLIAM S. DUTTON, Chairman

Report

"Delaware realized early that food is as important to victory as bullets; that every pound and peck raised in home gardens would release that much more of the country's regular food supply for the boys at the front; that putting idle ground to work for defense would help to conserve rubber and gasoline, provide recreation, and improve health.

"The Victory Garden Program also presented the opportunity to beautify home surroundings, help in the fight against ragweed, which causes millions of cases of hay fever every summer; and to supply some agricultural education to many who knew nothing about gardening.

"Every public-spirited organization in the State was asked to sponsor and supervise at least one Victory Garden Project, to be worked either by its own members or by facilities in the community, or by both.

"The plan was simple and direct and based one hundred per cent on volunteer service. People having idle ground were asked to lend it to gardeners. Those having large gardens were urged to share them with others. Backyard lots were turned into vegetable patches.

"But there was to be no needless plowing up of lawns, parks, and beauty spots—a mistake of the first World War. Only soil worth cultivating, as shown by tests, was to be put to work. Seeds, fertilizers, tools, insecticides, effort were to be conserved by intelligent supervision and instruction. A big aim was to prevent waste of anything, and save disappointments.

"A Garden Center was set up in Wilmington, under the direction of the State Chairman of Victory Gardens, to dispense information and literature on how to garden, and where necessary to aid people in obtaining seeds, tools, and fertilizers. Then similar Garden Centers were organized in each county, with branches in each community. The Centers answered thousands

of questions by telephone, more thousands in personal interviews. They kept good gardening advice immediately available to anybody who desired it.

"Classes were conducted for gardeners, new and old. The teachers were experts in soils, seeds, nutrition, fertilizers, pest control, and canning. They were supplied chiefly by the Agricultural Extension Service of the University of Delaware, the Wilmington Branch of the National Association of Gardeners, and Garden Club members. These organizations rendered splendid service throughout the Victory Garden Campaign.

"Through newspaper and radio publicity, lectures, and personal missionary work, the program was directed to the schools, 4-H Clubs, Girl Scouts, Boy Scouts, the Future Farmers of America, as well as to the average home owner or renter with a small backyard. Even apartment dwellers were urged to have gardens if land could be obtained at a small rental.

"After the plans were complete and gardens well underway, supervisors went on the job to see that the gardens were cared for, that Johnny didn't forget the gardens to go fishing, that each crop was picked at the proper time, and if feasible a second crop planted. In Delaware, many vegetable crops will give two seasons if followed in succession.

"Gardeners were urged to conserve their surplusses by canning, pickling and drying, or by proper winter storage. As an inducement to grow bigger and better vegetables and flowers, it was promised that Victory Garden Harvest shows would be held in the fall at which the best would be exhibited. Prizes were offered to stimulate competition.

"As a result, five Victory Garden Harvest Shows were held in the State in September and October. A small admission charge was made to each show and the proceeds were donated to the Army and Navy Emergency Relief Societies. Literally thousands of exhibits of fine vegetables and flowers were proof that the Victory Garden campaign was a success. A Certificate of Merit for outstanding work agriculturally was awarded by the Governor of the State in each county. In every instance, the winners were young gardeners with little or no previous experience.

"As an outgrowth of the campaign, a second program has been launche din Delaware to establish emergency Food Banks at centers designated as evacuation points in the event of enemy air raids, invasion or natural disaster. Thousands of quarts of surplus Victory Garden products have been canned and are being placed in these banks for emergency use under the direction of the Red Cross Canteen Service.

"It is expected that the work done this year will be an invaluable foundation for next year's Victory Garden Program, when food grown at home will become doubly important because of the increasing seriousness of the farm labor problem and the greater need of the war, coupled with an acute transportation problem.

"Next year's program is well underway with the thought in mind that the greatest impetus to come in the future must be from gardeners who are now under 17 years of age."

SALVAGE COMMITTEE

J. STUART GROVES, Chairman

Report

"For September and October, the following tonnages were produced:

"This does not include scrap sold direct to scrap dealers by individual citizens. The General Salvage poundage is only that collected by the Farm Scrap Harvest, City Collection and the School Program during September and October.

"The Street Rail Removal in Wilmington netted General Salvage 3,900 tons and has been completed. The streets have not been fully paved, but we hope that this will be finished within the next few weeks.

"Each county in the State of Delaware received a U.S. War Production pennant for producing over 100 pounds per capita during this two-month period.

"General Salvage has been working in conjunction with the American Legion in getting old jalopies from back of homes, garages and gasoline stations. During the past month, over 100 of these jalopies have been scrapped as a result of this program. This netted about 200 tons of scrap. "The tin can collection was started in July and is improving each month.

"The Silk and Nylon Hosiery Collection through all retail establishments seems to be progressing fairly well. The cooperation of the Chamber of Commerce and the Delaware Retailer's Council has helped materially.

"Compiling actual poundage figures for General Salvage is a very difficult thing, as a great deal of scrap is sold direct to junk dealers. Much of our scrap goes to Pennsylvania and Maryland dealers also. However, our dealers in Delaware have purchased enough to put us over our quota."

DELAWARE STATE GUARD

PAUL RINARD, Adjutant General

Report

"In conformity with legislation passed for the 1941 Session of the Delaware State Assembly, the Adjutant General of the State was directed by the Governor to form the Delaware State Guard, a military organization to supplant the National Guard of the State of Delaware, all of which had been previously called into the Federal Service.

"The Delaware State Guard has accordingly been organized wit htwo companies of Infantry in the City of Wilmington; a company in the Town of New Castle; a company at Middletown, Delaware; a company at Dover, Delaware; and a company at Milford, Delaware.

"Ordnance and military equipment, other than uniforms, were furnished upon requisition by the Federal Government at the initial organization of the Guard. The State from emergency funds appropriated for that purpose uniformed the officers and the men of the various companies. This uniform has since been augmented by additional clothing issued by the Federal Government comparatively recently.

"The total strength of the Guard is approximately 450 men and 20 officers. It has been efficiently trained under the direction of Colonel J. Paul Heinel, the Commanding Officer, who has adapted their training to that recommended by the Commanding General of the Second Service Command.

"A number of our officers have attended the Tactical School for State Guard officers at Hackettstown, New Jersey, which is conducted under the direct supervision of Army Officers of the Second Service Command. We confidently believe that our State Guard is as ably trained and as well equipped as any of our neighboring states, and, although priorities have prevented the securing of some equipment, we feel that anything that is lacking at this time will shortly be furnished, and that the State may rest secure in the knowledge that it has a competent organization equipped to any emergency that it may be called upon to meet."

KENT COUNTY

J. WALLACE WOODFORD, Coordinator

Report

"The County is divided into thirteen defense areas centering around Defense Councils of the larger towns. I am enclosing a list showing their locations with names of the chairmen. Maps have been made of the entire county, and in most cases individual houses have been located thereon in the rural sections.

"In Kent County we have participated in all of the State tests and blackouts and have had a number locally. In practically all of these tests we have worked out incidents necessitating the functioning of all of our various units. Reports show that our County organizations carry out these incidents with a fair measure of success. First aid, chemical warfare and auxiliary police classes have been held through the County and have been well attended. We have also held a number of public meetings for the purpose of acquainting the general public with civilian defense operations.

"Civilian Defense officials and members of the organization throughout the County have been very cooperative and have shown whole-hearted devotion to their duties. Our most serious handicap is the lack of an adequate alarm system in the rural sections."

RURAL NEW CASTLE COUNTY

RALPH L. MINKER, Coordinator

Report

"Rural New Castle County citizens threw themselves wholeheartedly into the task of developing an adequate defense organization. The county was divided into twenty-four sectors each of which is known as a Defense Council with a Commander in charge of all the defense activities in his sector. The philosophy underlying this plan was to make each territory as nearly selfsufficient as possible. "The various services needed for a complete Civilian Defense organization have been enlisted and trained. The organization numbers approximately eighty-five hundred men and women, boys and girls. Volunteer fire companies, State police, school teachers and chemists have given unstintingly of their services in training personnel. Suffice it to say that this County is ready for any emergency that might develop."

Sussex County

EDWARD C. EVANS, Coordinator

Report

"Sussex County in the short space of one year has accomplished what was unbelievable only a short while ago. A complete Civilian Defense organization has been completed and is the outstanding active organization of the entire county.

"Over ten thousand men, women and teen age boys are active in some branch of this organization. The rest of the county's population is engaged in helping those actively interested in seeing that the many rules and regulations imposed are obeyed.

"Twenty-two separate councils have been organized throughout the county and each has its own complete personnel from warden to control center. All operate as separate units and are ready at an instant's notice to answer the call either in their own locality or to travel many miles to aid a stricken neighbor and yet be prepared to carry on in their own town should aid to another locality be required.

"Many hours have been spent by competent instructors, teaching the various units in the many towns the many courses required in order that the members may be properly qualified and be eligible to carry the proper identifications awarded to those who pass.

"A central control center is located in Georgetown and all tests are dispatched from there to the local control centers in the county. This central control is manned twenty-four hours a day and all local control centers are so arranged that calls to them are immediately answered. Some are located in Police Stations; others are in private homes, but above all they are ready at an instant's notice to receive the calls dispatched.

"Two handicaps have been with us throughout the entire year. One, the lack of proper equipment for actual emergency; the other, the lack of an adequate system of warning for our rural localities. The equipment situation has, however, been eased somewhat within the last month with the coming of O. C. D. allotsments to some of the critical areas. This however, is not sufficient for the full twenty-two councils.

"We are now about to complete and will be ready at the next call with a rocket rural signal system that will cover every home outside municipal areas.

"Many blackout and daylight alerts have been held throughout the county during the year—many individual ones in the various towns, together with surprise ones arranged without knowledge to any member of the individual council affected and carried out by the Coordinator. In every case the town tested showed that it was on its toes and ready to go at an instant's notice. Many county-wide blackouts have also been held in addition to one from Dusk to Dawn, in which the entire county participated to the last man.

"While there is much still to be done, and our organization is not perfect, I feel that everything has been done that is possible to do, taking everything into consideration. One thing in particular that stands out prominently even though there has been no emergency, and we hope there never will be is, that the spirit of activity has never waned but continues to grow as the months pass."

COMMITTEE ON CONSERVATION OF CULTURAL RESOURCES LEON DEVALINGER, JR., Chairman

Report

"This Committee is organized with a number of persons having in their care valuable State, county and municipal records, paintings, and other material, and made surveys and recommendations for the preservation of the cultural resources within the State in the event of enemy bombing, fires, etc."
