REPORT OF SPECIAL COMMITTEE VISITING STATE INSTITUTIONS

February 24, 25 and 26, 1943

Departing from a custom which had closely been adhered to for a number of years, a joint committee, comprising some 23 members of the House and Senate visited the various State Institutions last week. Hitherto, the tour was made by the entire membership of the Legislature.

We, the committee from the Senate, believe that the smaller group works well. We do, however, recommend that at least another day be added to the time allowed to visit the institutions; for, it is our opinion, three days is too short a time.

The Blind Shop

The inspection tour opened with a visit to the Blind Shop, operated by the Delaware Commission for the Blind, with Dr. Francis Cummings, of Wilmington, in charge. Working in a building that has been condemned as unsafe and a fire hazard by city authorities, Dr. Cummings is doing a wonderful job with the blind unfortunates of this State. Although there are only seven persons now working at the shop, much material is sent out to other blind people residing in the City of Wilmington, and seven former employees of the shop are now successfully working in private industry. This program of placing the blind in private industry was successfully inaugurated by Dr. Cummings a short time ago, and several more of the physically able blind will be placed with private industry in the near future.

Brandywine Sanatorium

From the Blind Shop the group went to Brandywine Sanatorium where Dr. L. D. Phillips, superintendent, and L. Irving Handy, business manager, conducted the tour. There are approximately 130 persons now receiving treatment at the Sanatorium. Needs of the institution were explained by Superintendent Phillips with particular stress being laid on the lack of recreational facilities. Mr. Handy said that in the last couple of years there has been an approximate 30% increase in the cost of operation. The group noted with interest, that the sanatorium management had stripped all of the windows and glass doors in the institution as a possible precaution against bombing raids.

The members of the committee were shown many of the scientific devices used in combating the white plague, the most interesting of which was the fluroscope. Dr. Phillips stated that the help situation was most acute.

Edgewood Sanatorium

The next stop was Edgewood, the colored tuberculosis sanatorium. Here the group found crowded conditions, with beds placed too close together because of lack of adequate space. Dr. Conwell Banton assisted with the tour and showed the methods used in the deflation of diseased lungs. The committee was joined at Brandywine by Mrs. Julia H. Tallman, vice-president of the State Board of Health, and Dr. Edwin Cameron, both of whom furnished valuable information regarding the needs of both Brandywine and Edgewood.

The committee lunched at the Wilmington Country Club.

Ferris Industrial School

The next stop on the tour was the Ferris Industrial School where we were told by Superintendent Ralph Minker that the largest number of commitments in the history of the institution were made in 1942. In addition to his supervising duties at the institution. Mr. Minker acts as army registrar and related that boys reaching the age of 18 are inducted into the service. Most youths, according to Mr. Minker, seem eager to serve their country and he receives letters daily from youths serving in the armed forces, who are now making good in the army. Here the committee found many of the buildings in a more or less delapitated exterior condition. The majority of these buildings were over age. However, it was the concensus of opinion that the superintendent, with his repair and paint squads, had done a good job on the interior and the buildings were clean. Because of oil shortage, the committee was told the large laundry was forced to operate three days a week instead of five. However, under capable management, the work is being satisfactorily completed. The committee recommends that the pound, adjacent to the stable. be cleaned up as a sanitation measure.

Approximately 150 youths, between the ages of 10 and 21, are housed in the numerous cottages.

Workhouse

Moving on to the Workhouse, the committee was joined by His Excellency Governor Walter W. Bacon. The tour of the Workhouse was conducted by Robert D. Kemp, president of the Board of Trustees, and Warden Elwood H. Wilson. There are 321 prisoners in the Workhouse. Two-thirds of them are colored. Conditions at the Workhouse were good. The building, despite its age, is in excellent condition. The food served is of high grade and the sanitary arrangements were found to be above reproach.

A contract to furnish the U. S. Army Quartermaster Corps with 32,000 shirts had just been secured and several more large government orders are the offing. It was explained to the committee that the Armiy had requested a sample of a shirt made at the institution and was so pleased with the high grade of workmanship, that it placed the aforementioned order without reservation.

Visiting the women's prison, the committee found there plenty of vacant rooms, there being only 19 women incarcerated there. Sixteen of these are colored and three white. Of the white women, all will be released before the 15th of this month. This building is of modern design and was scrupulously kept.

Industrial School for Girls

The first day's tour ended at the Industrial School for Girls at Claymont. Here the tour was conducted by Miss Sara E. D. Sturgis, superintendent. There are approximately 50 girls enrolled. There is no evidence of over-crowding here. In fact, there were several vacant rooms on each floor. The buildings were neat and the girls were being given ample opportunity to learn trades. Many of the girls were preparing to participate in a birthday party and all seemed to be busily employed. This institution has set up a most efficient blackout system which we recommend being adopted by the other State institutions.

Industrial School for Colored Girls

Thursday morning the group visited the Industrial School for Colored Girls at Marshallton, where there are 58 girls enrolled. Special attention is being given to each individual girl at this institution and the superintendent, Mrs. Doris Fassitt, is to be complimented on the fine job of rehabilitation she is doing. Speaking to the group as a whole, Mrs. Fassitt told of several case histories and through her untiring efforts many of the girls committed to this institution have been able to gain and regain their position in society. The buildings were neat and the girls werebusy.

University of Delaware

Arriving at the University of Delaware shortly before noon, the group was taken on a tour of the many buildings comprising the State's University. At Women's College, a group of junior and senior girls aided with the tour, and the members were favorably impressed with the handsome buildings and fine equipment there. While time would not allow a thorough examination of the many buildings comprising Men's College, those examined were meticulously kept and it was the concensus of opinion that nothing is being left undone to fit the young idea to successfully compete in the world of business, science, etc., if he or she takes advantage of the opportunities that are afforded them at the University of Delaware.

Lunch was served at Old College and it was here that Dr. Hullihen, president, explained that contrary to newspaper publicity, which has created the erroneous impression that the college is taken over by the Army, there would be no change in other portions of college training aside from the special Army training. Next term the enrollment of men students, according to Dr. Hullihen, is expected to be less than 250. This would mean a loss of 400 students and a loss of \$80,000 in revenue, thus the contract with the Army would assure the college of not running a deficit. Dr. Hullihen said that the General Assembly had, both in the present and in the past, been most generous in appropriations. This, coupled with donations from wealthy citizens in the State, had done much to give the University buildings that are second to none in equipment and design.

Senate Bill 123, which has been introduced before this body by our colleague, Dr. Rhodes, and relative to corporations awarding academic degrees, was explained by Dr. Hullihen, who stated that neither he nor the trustees of the institution had any selfish interests involved, but were merely acting as interested citizens who wish to protect the vital interests of the State. According to Dr. Hullihen, the present General Charter Law gives any three people within the State the right to purchase a charter and give out degrees. At present there has been chartered a University of Dover, an International University of Delaware, and the Sulgrave University of Delaware; all of which are non-existent and were created by unscrupulous individuals as a money-making proposition. Especially odious is the Sulgrave University, which, according to Dr. Hullihen, is selling degrees in England. Dr. Hullihen stated that there is hardly a day passes in which he does not receive some inquiry from abroad asking about these bogus universities which, until the enactment of Senate Bill 123. will continue to award degrees for a price.

Of particular interest was the demonstration of the latest thing in anti-aircraft cannon—a Bofors 40 Millimeter, automatic rapid fire. This gun has been loaned to the University by the Government, and will provide practical training for the men.

Delaware State Hospital

Dr. M. A. Tarumianz met the group at the Delaware State Hospital at Farnhurst and personally conducted the group through the many buildings comprising this vast institution. Approximately 1,250 persons are receiving treatment at the State Hospital. The main and oldest building is extremely overcrowded and, while all is being done to keep the building sanitary, there were noticeable odors of human excrement on the second floor of the building, where badly deteriorated male cases are confined. While the committee realizes the almost unsurmountable difficulties which Dr. Tarumianz is confronted with, we do decommend that a more adequate system of ventilation be employed. This, coupled with the use of a chemical deororizing agent, would undoubtedly relieve this situation.

The wooden stairway in this building is a decided fire trap and as soon as funds can be made available, should be removed and replaced by metal or some other fire-resistant material. Until such time as this change can be made, they should be barred to the use of all others excepting those unemployed as doctors, nurses, etc., by the superintendent.

The kitchen, one of the largest in any of the State institutions, was scrupulously clean and the food served is of high quality. The operating costs of the institution, considering the high prices now prevailing for food, drugs, coal, and other commodities, is extremely low, being approximately \$1.15 per patient, per day. Dr. Tarumianz is operating the institution under a great handicap, so far as help is concerned, and without the services of 25 conscientious objectors and 4 of their wives would be forced to dispense with several treatments that are now being given to the patients.

Speaking as president of the Council of Executives of State Agencies, Dr. Tarumianz went on record as favoring a 15% salary increase for school teachers, but declared that such an increase, together with the retirement system, should be extended to cover all State employees.

Upon leaving, each member of the visitation committee was presented with a gift by Dr. Tarumianz. The gifts were made by patients in the institution.

State Welfare Home

Friday the members of the joint committee visited the State Welfare Home at Smyrna and were conducted through the building by Dr. A. V. Gilliland, superintendent, and George S. Grier, a member of the State Old Age Welfare Commission. There are approximately 371 guests at the home, including many more males than females. At present there are approximately 15 on the waiting list.

This institution is decidedly overcrowded with many of the hallways utilized for sleeping quarters. However, the building is well kept, both within and without, and the larder was well filled with fresh and canned foods. The meals are carefully prepared and the food is plentiful and nourishing. In spite of rising cost of food, drugs, fuel, etc., the low per capita of \$1.02 has been obtained, and through expert management, it has been possible to serve three meals per day at a cost of less than 10° per meal.

It was while visiting this institution that the members of the joint committee were really given the opportunity to see how the war has played havoc with the help situation. Here a girl has stepped into the breach and is firing the huge boiler in the institution's power plant. The girl, Miss Margaret Sammons, age 22 years, has successfully filled the position of telephone operator, floor assistant, and file clerk, and has now donned a sweat shirt and dungarees to do a real he-man's job and do it well. Another girl is pinch-hitting for the barber who is now serving in the armed forces and is shaving the men like a professional.

Delaware State College for Colored Students

Arriving at the Delaware State College for Colored Students, the committee was greeted by Elwood Melson, chairman of the board, and Dr. Howard Gregg, president of the College. After a visit to the auditorium, where the group was entertained by the choir, Mr. Melson, Dr. Gregg, Dr. W. M. Henry, Dr. O. F. Collins and Ernest V. Keith, Esq., members of the Board of Trustees, explained some of the needs of the institution. The outstanding of these is a new building for dormitory purposes, erection of which would entail the expenditure of approximately \$60,000 to \$75,000, and for which no provision has been made in House Bill No. 8. The committee thinks this is a just need and urges that House Bill No. 8 be amended to include this item. Another need of the institution is a field house. According to Dr. Gregg, there are approximately 250 students enrolled at the college; 148 in the college proper and 102 in the high school. Twenty-one male students of the college have been inducted into the armed services since Christmas; thirty-one more await the call in the enlisted reserves.

The guildings at the college are well kept and neat, both within and without, and the livestock and chickens are thriving. Since coming to Delaware State College, Dr. Gregg has done much to improve conditions, and last summer and fall, had canned and put away for later consumption 3,200 half-gallon cans of vegetables and fruits. This year, Providence permitting, the doctor hopes to can 6,000 half-gallon jars of produce raised on the farm.

A delicious luncheon was prepared and served by the Home Economics Department of the College.

Delaware Colony

The committee wound up the inspection tour at Delaware Colony where they were met by Howard T. Ennis, Superintendent; J. Edward Goslee and J. B. Waples, members of the Board of Trustees. The buildings at Delaware Colony are extremely well-kept. The morale is high and Superintendent Ennis is apparently doing a splendid job.

Approximately 467 persons are housed in nine buildings. There are three buildings for white males; three for white females; one for colored males; one for colored females and infirmary. The infirmary has an average daily population of about 65. The children are given academic training, occupational and vocational therapy; are given an opportunity to learn trades and many have been discharged and have taken up trades. About 35 childre nare discharged annually, with about the same number being admitted. The total number of employees at the present time is 80. We were advised that there is a shortage of the regular quota of about 15 employees.

Of especial interest was the fine herd of dairy cows which supply the institution with plenty of rich fresh milk daily. A large herd of swine solves a portion of the meat problem.

The total land area of the institution is nearly 1,100 acres with 450 under direct cultivation. While darkness caught the members before they could visit all the buildings comprising this large institution, the members were unanimous in their opinion that Delaware Colony is being carefully operated by Superintendent Ennis.

Conclusion

In conclusion, the members of the Senate, who made the trip, were for the most part pleased with the operations of the State institutions. It is the general opinion, however, that the next visitation be made prior to the passage of the general appropriation bill.

Mr. Bunting moved that the Senate adjourn until 12 o'clock noon, March 8, 1943.

REPORT OF THE

PRESIDENTS AND EXECUTIVES

OF ALL

STATE AGENCIES

March 10th, 1943

To the Honorable Members of the One Hundred and Ninth General Assembly

Gentlemen:

On July 7th, 1941, His Excellency, Walter W. Bacon, called a meeting of Presidents and Executives of all State Agencies. At this meeting the Governor requested all to contribute their best thoughts and energies for creating and preserving good standards for all agencies and at the same time eliminating duplication and unnecessary work, curtailing all capital improvements and striving for better inter-agency cooperation.

For the first time in the history of the affairs of the State of Delaware such an approach and appeal was made by the Chief Executive, thus giving to all, who are responsible for the welfare of the people an opportunity to work out a plan through which far fetched theories could be eliminated and the application of practical methods could be considered.

At this conference two councils were organized, "The Council of Presidents of all Boards of State Agencies" and "The Council of Executives of all State Agencies."

These Councils met regularly. At the meetings the Executives began the task of understanding each others problems, and helping the individual organization to so conduct its work that it would be of benefit to the whole.

During the first few months the Council considered all its problems on the basis of pre-war conditions, while during the last year the Council considered many problems directly involved with our entry in the war; such as, assisting the community, air raids, problems of evacuation and sanitation, blackouts, lack of sufficient help, increase in salaries and wages, adoption of a minimum and maximum salary scale for all services in all departments of the State, having in view that the salary scale of professional and non-professional State employees should be of such a nature as to compare favorably with that of private organizations, thus preventing disruption of State organizations through competition ; establishment of a reasonable retirement plan for all State employees, providing some future security, which will be an inducement for many efficient and good employees to remain at their posts during economic fluctuation. national or international in scope; to establish a special state emergency fund with provisions to meet the present and future critical situation of institutions and agencies created by war, which situation in some instances was quite alarming, since some agencies cannot maintain their services on more than 50%of the standard level; creation of a special commission to establish minimum requirements for all state positions, (post-war procedure), post-war building program and many other problems.

Both Councils studied the above problems very carefully and submitted their report to the Governor for his consideration, approval and presentation of the same in toto or in part to your Honorable Body. In preparing the post-war building program for our State, the members of the Council of Presidents of all Boards of State Agencies and of the Council of Executives of all State Agencies considered the problem as one composed of many branches closely interwoven. Recognizing the fact that our State has been in need of such a program for the past 15 years, considering also that many organizations of the State have approached the previous State Legislatures with building plans, but with an inadequate technic of approach, the members of both Councils have decided to work together with only one aim, to provide sufficient facilities not only for normal children and adults, but also adequate care of sick, feeble-minded, old, delinquent and severely maladjusted members of our community.

Our extensive post-war program included many new buildings, remodeling of old buildings, additions, etc. This proposed plan required a total sum of \$2,256,000.00.

After many meetings with the Governor, we presented our modified first part of the program which consisted of buildings incorporated in House Bill No. 8. This Bill will not only establish means for satisfactory care of those who are badly in need of such, but also will create opportunity for many of our citizens to find adequate work immediately after the war.

The Bill includes the following buildings for the different State agencies:

For the Delaware State Hospital, a special building for Alcoholics and Drug Addicts without Psychosis, at the cost of \$50,000.00 (this will solve the problem of the forgotten men and women who have no opportunity in this State to be treated and become adjusted); one special building for Epileptics without psychosis, at the cost of \$75,000.00, thus eliminating the commitment of such cases to the Delaware Colony for Feeble-Minded, since epileptics are fundamentally sick people and require hospitalization; one special building for children who require special hospital care for mental illness, at the cost of \$34,00.00; a complete new negro unit which will provide space for 270 male and female colored patients as well as quarters for negro doctors, nurses, attendants and other employees at the cost of \$350,000.00.

For the Delaware State Welfare Home, one building for 150 colored male and female guests and one special building for 60 white female guests. These two buildings will create sufficient space in the main central building to take care of physically ill members of the middle class and indigent who cannot be cared for in general hospitals because of the exorbitant cost. The expenditure of \$175,000.00 is required for the erection of these two buildings.

The Delaware State Welfare Home will also require a sewage disposal plant which will cost \$25,000.00. For the Delaware Colony for Feeble-Minded, two buildings for 80 boys and girls, at the cost of 80,000.00, and one building for vocational and occupational shops to accommodate 60% of the school's children, at the cost of 70,000.00.

For the Brandywine Sanatorium, one building for 20 male employees, at the cost of \$15,000.00.

For the Ferris Industrial School, one building for 40 boys who are now housed in the gymnasium, at the cost of \$35,000.00.

For the Industrial School for Colored Girls, one building for 30 girls at the cost of \$25,000.00 and a sewage disposal plant at the cost of \$3,000.00.

For the University of Delaware—Department of Agriculture, the construction and equipment of a building at the Agriculture Sub-station in Sussex County under the direction of the Board of Trustees of the University of Delaware for the purposes of establishing a poultry unit, at a cost of \$3,000.00; greenhouses, headhouses and ranges at the cost of \$50,000.00 and a poultry laboratory and service building at the cost of \$10,000.00.

The total sum incorporated in the Bill is \$1,000,000.00. However, we are requesting your Honorable Body to consider very seriously an additional building for the State College for Colored Students, for the sum of \$60,000.00 which has not been included in the above Bill.

We are urging you gentlemen to react favorably to the above mentioned House Bill No. 8, thus enabling all State hospitals and institutions to materialize to a certain degree the desire of many members of our community, who are directly or indirectly interested in the welfare of these institutions, and who are well aware of the importance and the necessity of adequate housing of sick, old, delinquent and deficient members of our State.
