An Act proposing an amendment to Article IV, Section 3 of the Constitution of the State of Delaware, relating to the Appointment of the Chancellor, Chief Justice and Associate Judges.

Which was given first and second reading, the second by title only, and referred to the Committee on Judiciary.

Mr. McGuigan, on motion for leave, introduced Senate Bill No. 203, entitled:

An Act proposing an Amendment to Article III, Section 9 of the Constitution of the State of Delaware, relating to Appointment by the Governor and the Filling of Vacancies.

Which was given first and second reading, the second by title only, and referred to the Committee on Revised Statutes.

Mr. McGuigan, on motion for leave, introduced Senate Bill No. 204, entitled:

An Act proposing an amendment to Article XI, Section 3 of the Constitution of the State of Delaware, relating to Commissioners of Agriculture.

An Act to amend Chapter 74, 2804, Section 3 of the Revised Code of the State of Delaware, 1935, as amended, relating to the Duties, Powers and Restrictions of the Board of Game and Fish Commissioners so as to Increase the Percentage of said Board's Income to be Expended on the Liberation of Protected Wildlife.

An Act to amend Chapter 185 of the Revised Code of Delaware, 1935, relating to Beauticians and the Conduct of their Business in Delaware.

Which was given first and second reading, the second by title only, and referred to the Committee on Revised Statutes.

Mr. Yerkes, on motion for leave, introduced Senate Bill No. 220, entitled:

An Act Authorizing the Levy Court of Kent County to Appropriate County Monies to David C. Harrison Post No. 14, Inc., American Legion, for the Maintenance of Ambulance.

Mr. Binder, on motion for leave, introduced Senate Bill No. 227, entitled:

An Act to provide for the Appointment of a Conservator, under Certain Circumstances, for Property of Persons Serving in or with the Armed Forces of the United States.

Which was given first and second reading, the second by title only, and referred to the Committee on Judiciary.

Mr. Binder, on motion for leave, introduced Senate Bill No. 228, entitled:

An Act to provide for the Receiving as Prima Facie Evidence in Any Court, Office or other Place in this State, Official Findings, Records, Reports, or Certified Copies thereof, of Death, Presumed Death, Missing or other Status, issued by the Secretaries of War and Navy and other Federal Officers and Employees.

Which was given first and second reading, the second by title only, and referred to the Committee on Judiciary.

Mr. Binder, on motion for leave, introduced Senate Bill No. 229, entitled:

An Act to Empower and Direct Municipalities and other Political Subdivisions to Promulgate, Administer, and Enforce Airport Zoning Regulations Limiting the Heights of Structures and Objects of Natural Growth, and otherwise Regulating the use of Property, in the Vivinity of Airports; to Authorize the Acquisition, by Purchase, Grant, or Condemnation, of Air Rights and other Interests in Land; and to provide Penalties and Remedies for Violations of this Act or of any Ordinance or Regulation made under the Authority conferred herein.

Which was given first and second reading, the second by title only, and referred to the Committee on Municipal Corporations.

Mr. Binder, on motion for leave, introduced Senate Bill No. 230, entitled:

An Act to amend Chapter 93 of the Revised Code of Delaware, 1935, providing for the Proof of Wills where Subscribing Witnesses are Unavailable, by Reason of Service in the Armed Forces of the United States.

Which was given first and second reading, the second by title only, and referred to the Committee on Judiciary.

Mr. Hitchens, on motion for leave, introduced Senate Bill No. 231, entitled:

An Act to amend Article 1, Chapter 44, Revised Code of Delaware, 1935, as amended, relating to Valuation and Assessment of Property by Exempting Certain Improvements on Public Lands of the State of Delaware.

Which was given first and second reading, the second by title only, and referred to the Committee on Public Lands.

Dear Governor Bacon:

A few weeks ago Mr. W. Emerson Wilson, City Editor of the *Wilmington Morning News*, telephoned to this office and asked us to assist him by giving an explanation of the difference between the number of sessions of the United States Congress and those of the Delaware Legislature. I explained over the telephone that this difference was caused by the fact that from 1776 until the constitution of 1831 the Legislature met annually and from that time on the meetings were biennial. In computing the

number of sessions on this basis Mr. Wilson still did not arrive at an answer that corresponded with the number of the present session of our Legislature. He then requested that we check this information more closely for him.

Upon looking into the subject carefully we found that in 1913 an act was passed (Laws of Delaware, Volume 27, Chapter 15) requiring the Secretary of State "to ascertain the number of regular sessions held by the General Assemblies of the State of Delaware, and that the General Assembly of the State of Delaware now in session shall be officially known by that number, and that all subsequent Biennial Assemblies shall be designated by number in sequence thereafter." In conformance with the terms of this act we examined our records from the beginning of statehood in 1776 and found that regular sessions of the General Assembly were held from October of 1776 to October of 1791, inclusive, which accounted for sixteen sessions. No regular session was held in 1792 because of the adoption of the new State constitution in that year. In January of 1793 regular sessions of the General Assembly began and continued annually until and including 1833. This accounted for forty-one additional sessions, or a total of fifty-seven. In January of 1835 the sessions began on a biennial basis, in accordance with the Constitution of 1831, and have thus continued to the present time. Since the first biennial meeting in January of 1835 there have been fifty-six regular biennial sessions, or a total of one hundred and thirteen regular legislative sessions held following the adoption of the first constitution of our State in 1776.

Thus it can be seen that the present session of the Delaware Legislature is the 113th Session instead of the 110th Session. We presume this discrepancy in the number of sessions was made in the Secretary of State's office in 1913 due to the fact that as many of the State's archives were not available then as now and were not as readily accessible. At a recent meeting of our Commission this discrepancy in the number of sessions was pointed out and I was requested to call it to your attention with the suggestion that a resolution be adopted by both Houses of the Legislature now in session to the effect that the next regular session in 1947 shall be designated as the 114th instead of the 111th Session.

RESOLVED by the Assembly and the Senate of the State of Nevada, jointly, That the Congress of the United States be, and it is hereby, memorialized to amend the present restrictions in the social security act to the end that any person who receives or is eligible to receive old-age assistance shall be permitted to do and perform odd jobs of labor, care-taking, and similar classes of casual work not in the general course of a trade or business, at such rates of pay commensurate with their abilities to perform the same, but in any event, in an amount not to exceed twenty-five (\$25) dollars in any one month without being penalized therefor; and be it further
