As a dozen city officials gathered to celebrate the opening of the McKees Solar Park, early-season snow flurries gave way to sun-

Man, 20, slain in botched robbery

Alleged accomplices arrested; shooter still at large

The 20-year-old Newark man who was shot and killed in a fast-food restaurant parking lot last week was armed with a semi-automatic rifle in what police are calling a "drug-related robbery.

Authorities say Marcus Johnson and three others went to the KFC on Marrows Road on Nov. 13 with the intention of robbing an acquaintance.

Instead, Johnson was shot and killed during the confrontation outside the restaurant, according to Lt. Mark A. Farrall. As Johnson lay dying in the parking-lot, his three alleged co-conspirators fled.

Those interested in burning some calories before the big family feast can take part in the 41st-annual Turkey Trot run/walk on Saturday at Handloff Park on Barksdale

The 5K and 10K race is the second-oldest consecutively-run race in the state.

Pre-registration on or before Nov. 19 is \$20, while day-of-race registration is \$25. The first 800 registrants receive a longsleeve T-shirt.

Check-in and day-of-race registration begins at 8 a.m. for 10K runners, with the race beginning at 9 a.m. For the 5K run and walk, the start time is 10:30 a.m. and check-in begins at 8:45 a.m. The event is rain or shine.

Prizes will be awarded to overall race winners, as well as winners in age group categories for each run, and random giveaways will include more than \$2,000 in prizes donated by local businesses.

A portion of the proceeds from the Turkey Trot will go to the James F. Hall Scholarship Fund. In addition, the Ancient Order of Hibernians will be collecting coats for people in need throughout the area at the race. Police re-establish toll-evasion patrols on Christina Parkway



Newark and state police have re-established toll-evasion patrols on Christina Parkway now that a definition for "local deliveries" has been drafted.

Now through the end of January, Newark and state police will be pulling over trucks on Christina Parkway between South College Avenue and Elkton Road, and ticketing those that are heading more than five miles outside city limits to make deliveries.

By law, the stretch of road is off-limits to vehicles weighing more than 9 tons, with the exception of trucks making "local deliveries." However, enforcement patrols temporarily ceased over the summer after it was discovered that the Delaware Department of Transportation had not defined what is considered "local."

After consulting with Del-DOT's attorney, City Solicitor Bruce Herron drafted a new definition of "local" that includes trucks making deliveries within city limits or within five miles of the city limits, and trucks heading directly

within five miles of the city.

Last month, DelDOT signed off on the new parameters and agreed to spend up to \$43,000 for Newark police and up to \$45,000 for state police patrols from Nov. 1 through Jan. 31. NPD spokesman Lt. Mark

A. Farrall said that throughout the 13-week patrol period, officers are looking for trucks on Christina Parkway that don't meet the city's definition of "local," such as longhaul truckers traveling from Maine to Florida. Truckers often get off Interstate 95, travel Christina Parkway and then get back on the interstate in Elkton, Md., thus avoiding the toll at the state line.

"They don't have any professional business in the city of Newark," Farrall said.

Officers will also be looking for equipment violations, as well as checking classifications and log books.

Farrall said a patrol schedule has been established, and

from a delivery in the city or truck drivers can expect to see officers regularly on the lookout for the next several

> "They're pretty much out there every day," he said.

According to DelDOT Chief Traffic Engineer Mark Luszcz, the enhanced enforcement is considered a "pilot program" and will be revisited at the end of January.

He said DelDOT will determine if the patrols have made any impact on toll revenues and take data from police into consideration when deciding whether to extend the agreement with local and state authorities.

"Basically, toll revenue will be a prime factor in what we're looking at," Luszcz said.



Fitness trainer uses personal experience to motivate clients

When the clock ticks down and time starts to run out, that's when Leigh Anne Emrich ramps up.

Three more reps! You can do it! Six seconds left!" She shouts, encouraging each client in her class to finish the workout strong.

As a trainer at Fusion Fitness Center, Emrich, 34, is constantly motivating people to do their best by teaching Fusion's philosophy that "results are earned," and she should know.

Emrich, a Maryland native, played lacrosse at the University of Delaware and graduated in 2002 with a degree in psychology, but it wasn't easy. Like many college students, she struggled to maintain a healthy lifestyle until she decided to change

Emrich went back to UD to study nutrition and then realized her passion was back in the gym all along. It was then that she decided to pursue a career as a fitness trainer.

She became a certified personal trainer through the National Academy of Sports Medicine and worked with clients on her own before joining Fusion Fitness Cen-

Today, she oversees the en-"I know what it's like to see tire training program at Fusion, which includes seven trainers and more than 100 clients, and also teaches weekly team training and personal sessions.

"I'm on my feet all day and I'm being active," Emrich said. "I love it."

Each week, she meets with clients one-on-one to create workouts based on their limitations, injuries and goals, which are different for everyone, she said. While some people are looking for weight loss, others are just trying to reduce stress or get back to playing with their children or grandchildren.
On the other end of the

spectrum, she said, some clients come in with specific goals like competing in a marathon, triathlon, weight-lifting competition, beauty pageant or spartan race. Emrich draws up the workouts for the trainers, and the trainers take their clients through the exercises.

Emrich also has her own personal clients and teaches about 10 group workout classes a week, with about 10 people in each class.

In a typical session, she likes to have her clients start with a warmup before moving to weightlifting, mobility drills, core drills, a full-body circuit and finally a "finish-She said the "finisher" can be anything, like pushing a weighted sled, and is usually one of the hardest parts of the workout.

Throughout the session she is keeping time, counting reps and making sure clients are working hard by motivating and encouraging them. She also watches for improper form and demonstrates the correct way to do an exercise to avoid injury and get the best results.

"I'm fanatical about the form, probably too much," she said, laughing. "But I feel like it's my responsibility to keep my-clients safe."

Emrich has trained clients of all levels at Fusion, but said she really enjoys working with those who are new to fitness because it's a challenge. She said people often shy away from the gym because they don't understand it or have been exposed to the wrong information.

Clients who come in with preconceived notions and negative feelings toward going to the gym can be tough, Emrich said, but that's why she loves her job. Once they start to see results, their minds usually change, she

"It sounds cheesy, but it's an incredible feeling to get them to that aha moment," she said.

Working at a small gym like Fusion, Emrich knows nearly everyone's name. Over the years, she said, she has built strong, lasting relationships with her clients and staff, which is why she enjoys coming to work every


is difficult for her to deal with. As a trainer, she said, it's inherent in her to help people achieve their fitness goals and when they give up, she feels responsible.

"If you don't get results for them, you sort of feel like you've failed them," she said.


For Emrich, there's a type of energy inside the gym she likes, and she can't imagine being anywhere else.

He said InformMe now has more options for the types of alerts, with categories such as garbage, traffic, veather, plowing and road closures. Residents can log in to InformMe and pick and choose which alerts are important to them and which they would prefer not to receive, he said.

"Certainly we encourage people to opt-in to everything," he said.
With the new software, Nietubicz

said the InformMe service cost the said, residents can now sign up to re-

ceive additional notifications that will alert them of all city meetings that are open to the public, such as council meetings, planning commission meetings and board of adjustment meetings. They will also be notified of cancellations and changes to times and locations.

"That's a function that a lot of people asked for, and now we have the capability to do it," he said.

According to Nietubicz, approxi-

mately 2,454 people currently receive InformMe alerts and will need to log in and change their preferences for the upgraded software. New users are encouraged to sign up through the city website.

UD officials lay out plan for urban-inspired STAR Campus design

Professors and researchers disembark regional rail cars at the Newark train station and walk down a tree-lined promenade to get to work. Scientists from different disciplines mingle in parks and sidewalk cafes. Students work alongside professionals on cyber-security and other high-tech projects.

That's the ambitious vision for the STAR Campus that University of Dela-ware officials laid out last week.

The plan for an urbaninspired technology and research campus on the site of the former Chrysler assembly plant will take more than a century to be fully realized, officials

fore you will not be here ton, Brangman said. when this is finished," Vice Provost for Research Charlie Riordan said at a Nov. 13 community meeting about the master plan.

UD bought the shuttered auto plant in October 2009 and two years later released a more generic master plan that included the entire 272-acre site.

The most recent plan instead focuses on a 65-acre portion in the northeast corner of the site, near South College Avenue and the train station, with the remaining land labeled as "future development."

"It's just easier to eat that site in a smaller bite," said Alan Brangman, vice president for facilities, distinctive park. real estate and auxiliary "We don't w

Development to be split into five neighborhoods

UD officials don't want a typical business park setting in which individual buildings are separated by parking lots. Instead, Brangman said, the STAR Campus will better resemble an urban business district in a major city.

Planners developed grid of streets, and the development will be organized into five neighborhoods, some focused around mixed-use and some focused around research. Each will include a

be multi-story buildings, some as tall as eight floors. The upper floors will house research-based companies and office space.

UD hopes to lure companies doing research in areas such as health science, cyber security, alternative energy and infrastructure. All must provide educational and professional benefits to students.

In addition, the site will contain considerable retail space, restaurants, parking garages and, eventually, an eight-story hotel and conference center. It could also include residential space for Christiana Care interns, graduate students and junior faculty.

No dormitories or academic buildings will be built on the STAR

The only building currently on the 65-acre portion of the site targeted for development is the Health Sciences Building, which is located in a renovated building once used for Chrysler's administrative

The building contains Train station 10,000-square-foot physical therapy clinic as well as a nurse-managed health care center and a pediatric mobility lab.

Another portion of the building is under renovation by developer Ernie Delle Donne. It will be leased to tenants and is expected to include some type of restaurant. Delle Donne is also planning a second, taller building on the STAR Campus, Brangman said.

In the southern portion of the STAR Campus site – not included in the 65-acre master plan - is Bloom Energy, which opened last fall and manufactures "Bloom boxes" in which fuel cells are used to convert fuel

A major piece of the STAR Campus development relies on improvements to the Newark train station, which occupies the northern-most portion of the site. The station would help bring employees, students and customers to the science and technology campus.

Officials have long eyed an expanded transportation center with new platforms and a station building.

Plans for the station, approximately 1,200-feet west of the existing SEPTA depot, were released in June 2013 and showed a station in which passengers would take an elevator to a 26-foot-high platform and walk across a covered pedestrian bridge to the other elevator in order to get to the new platforms.

Construction was originally scheduled to begin this fall, but was delayed due to funding issues and negotiations with Norfolk Southern, which operates a rail yard adjacent to the station.

Brangman said he is optimistic the station could power the site.

UD also hopes to convince Maryland officials to expand MARC service an additional 18 miles from Perryville, Md., to Newark. That would unite MARC and SEPTA, allowing people to ride regional rail from Washington, D.C., to Philadelphia.

UD promises more due diligence in light of TDC controversy

The majority of the conversation about the STAR Campus in the past year and a half was driven by the The Data Centers' proposal to build a data center and combined heat and power (CHP) plant on the western portion of the site. The controversial project was canceled by the university this past summer.

Brangman said the controversy did not change the way UD approached plans for the STAR Campus, but said officials are trying to be more careful before supporting projects.

"Obviously, we're spend-

ing more time in our due diligence," he said. Still, the possibility of a CHP plant on the STAR Campus remains. The site plan always included such a facility, albeit one smaller than TDC proposed, Brangman said.

There are no definite plans for a CHP, but UD will keep its options open as development of the site moves forward, he said, noting that officials are also considering using geothermal energy to

City sets new guidelines for snow response

Neighborhood roads won't be plowed during minor storms

City crews will no longer plow most residential and subdivision roads during winter storms predicted to drop less than 2 inches of snow.

"We feel under 2 inches is navigable," said Tim Filasky, assistant director of public works. He added that the change will help keep expenses down.

The decision comes as the public works department looks to formalize its snow response. Previously, there was no formal plan other than a list of the five plowing routes.

'Nothing was written down," Filasky said. "Everything was in the mechanic's brain.

The 79-page plan, presented to city council last week, seeks to standardize the city's response to storms so people will know what to expect when the flakes begin to fall.

"If we formalize it, we can manage the expectations of residents and council," Filasky said. "We're trying to fend off a few phone calls.

The plan comes on the heels of a brutal winter last year that saw near-record snowfall. Last season's first winter storm, on Dec. 8, was predicted to be just a dusting but ended up dumping nearly 9 inches. Filasky acknowledged the city was caught off

"But if we're prepared, we can be ready for anything," he said.

The new plan divides winter storms into four categories, based on the predicted snowfall amount.

In the lowest category, under 2 inches, the city's response will be minimal

and focus on main roads with a "skeleton crew" of two plows. Neighborhood roads won't be plowed unless a problem, such as severe icing, is reported.


A prediction of 2 inches or more will trigger deployment of a full crew of six plows. During off-hours, crews will focus on main roads, but during hours when city crews are normally working, plows will also enter neighborhoods

Once predictions exceed 4 inches, crews will work multiple shifts and drive routes that touch all streets in the city.

Filasky emphasized that his department will be flexible and able to change its response if conditions de-

"Things can change rapidly when it comes to snow," he said

The new plan also adds a sixth plow route to focus on the downtown area.



Last year, council authorized spending a little more than \$600,000 to build the solar park, with some of that money coming from the green energy fund and the Conservation Advisory Committee. The project will eventually pay for itself through the avoided cost of buying wholesale power, the state's Green Energy Program and from the sale of renewable energy credits to the Delaware Municipal Electric Corporation (DEMEC)

Officials estimate it will take 28 months to pay off the project.

The solar park is also being funded by community contributions. More than 20 Newarkers donated a total of \$4,000 toward the project.

An additional 77 people made a \$50 "micro-investment" and, in exchange, will receive a \$1 rebate each month on their electric bill for the next 10 years. The city's goal is 200 micro-investors.

During the ceremony, Mayor Polly Sierer lauded those donors for "literally buying into our vision."



Fostering healthy youthadult partnerships

The concept of youth-adult partnerships appears to be simple and self-explanatory, however, its implications are very significant. According to a study from the University of California, youth that engage in youth-adult partnerships demonstrate an increased understanding of civic engagement, increased self-esteem and a decrease in risky behaviors.

Positive youth-adult partnerships are defined as youth and adults working together in a positive environment towards a common goal. These relationships are mutually beneficial to both the youth and adult participant. They occur when both youth and adults plan, work and learn together, usually striving to achieve a particular goal or complete a task.

In a traditional coach-pupil setting, adults assume leadership roles and youth are generally assigned certain roles. Youthadult partnerships are different than a typical coach-pupil relationship in that the youth and adults both take responsibility for various tasks. It is a collaborative effort instead of an authoritarian-style partner-

Be patient and forgiving

Regardless of their leadership skills and passion for the projects with which they are working, kids will, in fact, be kids. You may the youth, but if you are providing a safe a periodic column for the Newark Post.

and caring environment, you will eventually see the effects of the positive youth-adult partnership. You must be willing to be patient and accepting in the event that the youth makes mistakes or takes a different approach than you would on a specific task.

Stay positive

When working with a group of young people, find their strengths and reinforce these strengths with positivity. You can also work with the youth to identify their weaknesses and find ways to improve upon

Involve the youth

As mentioned, the emphasis and key factor for a positive youth-adult partnership is the word: partnership. Neither the youth, nor the adult, should take sole responsibility for an action. The responsibility should be shared. Include the youth equally in the decision-making process and allow for the

voice of the youth to be heard. Youth-adult partnerships can be incorporated in many ways including extra-curricular activities in school, sports, 4-H programs and much more. 




