Seat belt laws to be amended

In a first reading, the Mayor and Council, at Monday night's meeting, proposed amending the present seat belt and child restraint laws to conform with changes made in the Delaware Motor Vehicle Code.

The new measure will require children under eight years-old and weighing less than 65 pounds be secured with a properly designed restraint system. Children between ages 8 and 16 or who weigh over 65 pounds can be secured with a seat belt.

Additionally, provisions for front seat placement of chilfrom City Solicitor Roger Akin describes the new laws and states, "Children are prohibited from riding as frontseat passengers if they are under 65 inches in height or under 12 years of age and if they are riding in a vehicle with a passenger-side airbag which has not been properly disabled. Such a child may ride in a front seat if a passenger-side airbag has been properly modified to protect children and small adults."

Exceptions to this rule include vehicles without a back seat or if the entire rear seat is already occupied with

Meet the new director of the Newark Symphony

The new conductor of the Newark Symphony Orchestra is a warm and engaging young man whose Italian upbringing gives him a refreshing directness. "Italians usually express themselves and their feelings without filters," says Maestro Simeone Tartaglione. His unfiltered spontaneity has endeared him to the musicians of the NSO. "Last week, players were in awe when he started to sing the oboe solo with such clarity of voice and perfection of

tone. He now has the whole symphony putting down our instruments and singing our parts instead," says Kathleen Chapmond, violinist.

With two small children, one born quite recently, Tartaglione and his wife, Alessandra Cuffaro, have jumped into American life without hesitation. Having served as adjunct professor of conducting at the University of Denver and having studied conducting at the Peabody Institute in Baltimore, Tartaglione is not a newcomer. Does he feel there is a distinctive American approach to music? "In many ways, there is. In Europe, we have strong and valid traditions of how music should be performed, sometimes those traditions are somewhat too constricting. In

America you can use the same traditions, but musicians are more open to new approaches and experiments."

Tartaglione does not believe classical music should remain in an ivory tower. He plays for a church where he 'sneaks in a little opera'. He directs a group of musicians who call themselves the BE Orchestra - BE for BE involved. They take music to groups are not usually exposed to classical music. He is also on the board of the Chesapeake Chamber Opera which is trying to fill the hole left since the Baltimore Opera Company declared bank-ruptcy in 2008. The group now has many young mem-bers who are singing concert versions of operas in churches and other nontraditional venues. Tartaglione will conduct Engelbert Humperdinck's Hansel and Gretl on October 30 and 31.

So Newark should be prepared to have music delivered to them with gusto. The first program of the season on October 24 will have three romantic works: The Elgar Cello Concerto is one whose themes are quite familiar. Larry Stomberg, whose sonority is strong and striking, will be the soloist. Also on the program is Tchaikovsky's Fourth Symphony and the overture to Verdi's La Forza del Destino.

The maestro is working systematically with the orchestra - even having them do etudes and other exercises to improve intonation. "We do what every player does - warm up before playing. We just do it together to improve ensemble, intonation, articulation, readiness of response to the baton, " says

say that his passion for music is contagious and they feel so close to him, they call him by his first name.

Laura Rogers, violinist, says, "He is firm about increasing the NSO's listening skills, but does not scold or use shame to achieve his goals." Another reason the musicians like the new conductor is that he told them in his opening season letter, "I will always have my ear open to your ideas, concerns and suggestions." Laura Grass, veteran trumpet player and member of the NSO, says, "The orchestra will grow with him."



Shotgun fired during fight at party

An incident involving a shotgun took place at the Main Street Courtyard Apartments, 329 E. Main St, on Sunday, October 10 around 1:15 a.m. A resident of a third floor apartment returned to the building with friends and found a crowd of people on the common balcony area of the third floor. The crowd was apparently from a party. in a nearby apartment that had spilled out onto the balcony. A friend of the resident became involved in an argument, and then a physical fight with a

Michael Shuba

In response to the fight, the resident, Michael Shuba, 21, retrieved a shotgun from within his apartment. Upon exiting his apartment, he hit one person in the head with the butt of the gun and pointed the gun at that person, and then fired a shot into the air (the building has no roof overhead). The crowd quickly cleared from the building. During the incident, a window of Shuba's apartment was broken.

Responding officers found Shuba and the shotgun inside his apartment. During a subsequent search, a marijuana grinder and water pipe/bong were also found.

Shuba, who is not a student at the University of Delaware, was charged with Assault 2nd Degree, Reckless Endangering 1st Degree, Aggravated Menacing, Possession of a Firearm during the Commission of a Felony, Discharging a Firearm, and Possession of Drug Paraphernalia. He was committed to the Young Correctional Facility after failing to post a secured bond in the amount of \$50,150.

Teen tips over toilet with 7 year-old inside

A Newark area teenager faces a number of charges after being accused of tipping over a portable toilet with a seven year-old being forced inside the unit.

The juvenile, who resides on the 600 block of Postfield Drive in the community of Scottfield, southeast of Newark, has been charged with with unlawful imprisonment, assault and harassment after he forced a seven year old child into a "Port-o-John" and then knocked it over. The victim was trapped inside and injured. He was also covered in human waste.

On Sunday at 7:45 p.m., County Police went to a residence in the 100 block of Scottfield Drive for a report of an assault that just occurred. When the officers arrived, they talked with the father of the victim who reported his son and two other youths were approached by the juvenile as they were riding their bikes in Hann Park. The juvenile then threatened the victim and forced him into a portable toiler in the park.

After the youth was inside, the juvenile then intentionally pushed over the toilet onto the door so the victim could not get out. He then walked away as the victim was screaming to get out. His two friends (males ages 7 and 8) were able to lift the bathroom up enough for the victim to get out . The victim. who also suffered a minor

knee injury, then went home and told his father.

The juvenile was arrested at his home and charged with the above offenses. He has been arraigned and released to his parents on \$4,000 unsecured bail. He was also ordered to have no contact with the victim.

Five years Wilmington DART bus driver ended up being paralyzed when a portable toilet he was in was turned over.

A community effort led to the man having his house remodeled so he could more easily operate his wheelchair in the structure.

Apparent parts theft thwarted

Three New Yorkers are in custody after they were apprehended while preparing to steal parts from vehicles at a Newark car dealership early Tuesday morning.

A security officer working for Porter Nissan saw a van pull into the vacant Cleveland Heights neighborhood, but did not notice the van leave. (Cleveland Heights borders Porter Nissan). The guard notified the Newark Police. Dealerships in and around "auto row" have been hit a number of times by tire and other thefts in recent years.

Officers found the van parked in the rear yard of a house, near the fence line of Porter Nissan. The door to the van was open, and the officer saw a person inside. He was taken into custody. Cab driver robbed at gunpoint

Officers of the Newark Police Dept. responded to a robbery call early on Monday morning from a cab driver parked on Kinross Dr. The driver stated that a dark blue, four-door sedan, possibly a Toyota Camry, with Maryland registration, had stopped to ask for directions. The driver said that the car was driven by a light-skinned black male, with a white female in the passenger side and two black males in the rear area. All four were described as wearing dark hooded sweatshirts.

The female asked the cabbie for directions to a street he did not know. When the victim used his cell phone to call a friend, the sedan drove off. Several minutes later, as the victim was still in his cab, the sedan returned and approached the cab head-on. One of the rear passengers

exited the sedan, produced a handgun, racked the slide and demanded the victim give him all of his cash. The cab driver gave the suspect about \$400, his fare money from the weekend, and his Western Union card. The sedan sped off with the female counting the money as they left.

The suspect holding the gun was described as a black male, dark complexion, about 5'08", average build, clean shaven, with the hood of his sweatshirt up and wearing dark pants.

A search by police revealed little physical evidence beyond a fluid puddle in the place where the victim said the car had been parked.

The case has been turned over to detectives for further investigation.

Shoplifter makes off with Red Bull

Employees at Acme Market, located at 100 Suburban Dr., reported that a white male, 5'08" to 5'10" tall, with brown hair, a goatee, dressed in a Cincinnati Reds baseball cap, black tshirt that said "The Wedge", and blue jeans had stolen an unknown number of cases of Red Bull.

The suspect was seen loading the beverages into a shopping cart, left the store without paying for the merchandise, and loaded them into a green Pontiac with Maryland registration. The suspect entered the driver's side and sped out of the parking lot. A white male was reported to be sitting in the passenger's side of the vehicle.

A manager stated that he was unsure how much exactly was taken, but he estimated the amount at ten cases, or \$160 in worth.

The registration was traced to a residence and a male owner in Havre de Grace, MD, but the vehicle has not been located. A call to The Wedge restaurant verified that the t-shirt was one of theirs. No further information was developed on the possible suspect, but officers are still on the lookout for the car.



children under 65 inches and under age 12.

The ordinance outlines that a \$25 fine will be assessed to the operator of the vehicle. The violation will be considered a "civil" offense and also "secondary", meaning that an officer cannot stop a vehicle solely for violating the seat beat law.

Several amendments to ordinances were also read, for the first time, which will update multiple city codes by adopting the 2009 Edition of the International Property Maintenance Code, the 2009 Edition of the International Fire Code, and the 2009 Editions of the International Code Council, International Energy Code and the International Fuel Code.

All of the proposed ordinances will be read for a second time at the Council's October 25 meeting. In most cases, a vote is taken for final approval or rejection. To view the full text of the amendments, please visit www.cityofnewark.de.us.

City Planning & Development Director Roy Lopata, when questioned about the agenda change, stated in an e-mail to the Newark Post, "Our understanding is that the applicants and the landowners have not completed their review of the 'subdivision agreement;' which is the document that details the City's approvals and the applicants and landowners responsibilities as a project moves forward."

Candidates offer views at Newark forum

In Newark, a state senate and representative districts candidates forum on Saturday showcased differences on issues between the candidates. While agreeing on what are priority issues for Delaware, the candidates frequently proposed alternative ways to address prob-

All six candidates have strong, long-time ties to Delaware - living, working, and raising families in this state. For State Senate District 9 the candidates are: Robert Johnston (R), and incumbent Karen Peterson (D). Candidates for State Representative District 23 are: Terry Schooley (D), incumbent, and William Stritzinger (R). For State Representative District 25 the candidates are: John Kowalko (D), incumbent, and Gordon Winegar (R). At the end of Saturday's forum, moderator Al Mascitti of WDEL 1150 AM radio complimented all candidates, thanking them for answering all questions directly, not deflecting hard questions, and conducting themselves with civility throughout.

The economy in Delaware

was a priority topic. Winegar wants to find ways to eliminate waste. Kowalko asked those attending - "Which things you are willing to give up? Smaller class sizes? Tell me your priorities." Schooley stressed consolidation of services, and noted that state government is reducing costs through attrition. She also noted that Delaware has established a Business Finder's Fund, through which a business is incentivized to bring additional, often supporting businesses to Delaware.

Education in Delaware is who works at the University education results and other children's issues, stressed that not gone down. Stritzinger has a child in a charter school to operating a small business. Winegar has children in public



Restaurant, store openings continue at mall

The restaurant and retail openings are continuing at Christiana Mall.

Regional restaurant chain J.B. Dawsons opened on Wednesday. The casual dining spot got its start in Reading, Pa. as Austin's. Other restaurants are in Langhorne, Drexel Hil and Lancaster, Pa. The restaurant will have an outside entrance to the mall.

On Friday, Vera Bradley will open a store in the mall. The national company sells luggage, wallets, handbags and other items with bright colors that appeal to its female customer base. In November, Brio Tuscan Grill is slated to open next door to J.B. Dawsons. The restaurant will feature pasta, flatbreads, but not pizza, according to the menu.

The new Target opened in Christiana Mall over the weekend. While the formal opening is Sunday, Oct. 10th, the retailer held a "soft opening" for the store overthe weekend. Target opened 10 stores in recent days.

The store, which is at the site of the Lord and Taylor store, (that building was razed) will give Christiana a big boost, since Target attracts a wider range of income levels than many other retailers in the mall. Target also offers fashion

apparel, some from well-known designers. Its offerings also include groceries and a pharmacy.

Store and restaurant openings are continuing at the mall, with fashion designer Michael Kors opening retail space this fall. The flagship Nordstrom store that will complete the transformation of the mall will open in spring of 2011.

The mall is owned by General Growth Properties, which under went Chapter 11 bankruptcy proceedings during much of the renovation and expansion program. However, the mall, due in part to the ongoing construction work, was not part of the bankruptcy filing.

Target is reportedly only opening 10 stores this year as it remodels existing stores and adapts to consumers watching their spending. It is a fraction of the size of Wal Mart, but, of late, has benefitted from shoppers moving toward upscale dis-








Christiana grad takes on Warfighter Challenge

Not many people would put themselves through four days of extreme physical and mental exhaustion just to prove they are one of the best at what they do, but the son of a Newark couple recently did

Army Pfc. Dean R. Hunter, son of Bob and Cheryl Hunter of Arrowwood Drive, Newark, put his body and mind to the test during the Warfighter Challenge, an annual competition held to determine which of the 35 three-man teams can stave off pain and fatigue to be called the best in the Army's Military Police Corps.

"I decided to compete in this competition so that I could challenge myself and go up against the best of the best in the military police corps," said Hunter, a member of the 503rd Military Police Battalion, Fort Bragg, N.C.

The Warfighter Challenge kicked off with a physical fitness test consisting of three minutes of push-ups, sit-ups with 25 pound weights, chinups, and a six-mile run on the evening of day one and ended with a 15-mile endurance march with gear weighing as much as 40 pounds.

On day two the teams ran an obstacle course with 12 challenges, cleared buildings and detained suspected insurgents, spotted and reported improvised explosive devices hidden along paths, and performed a day and night land navigation.

Day three started out with a mixed martial arts style combatives tournament, zeroing weapons before completing a team move and fire event, driving in a simulator resembling driving a HMVEE through an urban environment and engaging targets and IEDs. The last event of the day was a night fire exercise.

Before the final 15 mile march on day four, the competitors had to take a written

range, doing CrossFit, weight lifting, running, ruck marching, and a lot of studying to get ready for the competition," said Hunter, a 2009 graduate of Christiana High School.

Even with all of the work before hand, there were one or two events that gave Hunter more trouble than the others.

'The final ruck was the most difficult event because I wanted to quit so bad and we were in first place. We eventually lost the lead because I was hurting so bad and had to slow down," said Hunter.

For Hunter, being a com-


petitor is an accomplishment, but winning the competition would make the four days of events that much more mean-


'Winning is very important because it is the most prestigious event among all of the military police corps," said Hunter, who has completed

one year of military service.

This week's Out of the Attic item is an October 29,1991 aerial view of the MBNA credit card complex in Ogletown. The Newark-Stanton Road (Route 4) crosses right to left and the Ogletown-Christiana Road (Route 273) extends from lower right upward in the picture. An A & P supermarket stood at the intersection of the old roads before the realignment shown here. In 1982 a group of executives working for FNC Financial in Baltimore formed a new company to issue and manage credit cards. Their first office was in the remod-eled A & P building. The building facing the intersection and along Route 4 was built to expand and surround the original. By 2005, in less than 25 years, MBNA had grown to be the largest independent credit card operation in the world with 25,800 employees worldwide including more than 10,000 in Delaware. On January 1, 2006, MBNA merged with and into Bank of

Newark faces high-flying Middletown squad

Newark High (2-3, 1-1 Flight A) hosts Middletown (4-1, 2-0 Flight A) Friday night at 7 p.m. in an annual rivalry that, while lopsided in the win-loss column, never fails to entertain.

It was in the late 1990s when Newark was racking up Division I state championships and Middletown was dominating Division II that fans from both schools wondered, "What if the two ever played each other?" But during those years the schools never met on the field, except for the occasional scrimmage, which Middletown coach Mark DelPercio says, "Were just like games."

Since Middletown moved up to Division I in 2002, the Cavaliers have won every regular-season game between the schools, including last year's one-sided 56-7 victory.

"This has always been a hard-hitting and competitive game," DelPercio said of the annual tilt. "We will be outsized and must look for any edge that we can find. Newark is an outstanding football team."

Middletown's fans travel well, and it's safe to say the visitors' bleachers will be packed. Add to the equation that it's Newark's homecoming, and this game will have the feel of a playoff atmosphere.

For Middletown, whose wins this season are over opponents with a combined 5-15 record, this game will serve as its second test. Middletown failed its first true test two weeks ago, losing 27-0 to topranked Salesianum (5-0). But the Cavs are coming off a strong 49-0 win over Delcastle (0-5). DelPercio said in order to be successful his team needs to keep the Newark offense off the field, which will keep the ball out of the hands of quarterback Taylor Reynolds.

"You can't stop him,"
DelPercio said of the talented
junior, "but only hope to contain him. We can't let him get
free and to the edge. He is very

elusive and has a great arm. He will be one of the finest quarterbacks we see all year."

Newark, which defeated Middletown 14-0 in the 2004 Division I state championship game, is coming off a 27-15 loss to William Penn (3-2). Head coach Butch Simpson said prior to that game, "We score a lot, but we give up a lot."

Newark will face a young, but talented freshman quarter-back in Darius Wade, whose main target is also a freshman, Chris Godwin. When he's not throwing the ball, Wade will hand it off to senior running back Michael West, who is averaging nearly nine yards per carry.

On the other side of the ball, Newark's offense will look to score against a Middletown defense that has shut out two Flight A opponents (Christiana and Delcastle). It's a daunting task, but one that Reynolds feels his team will be ready for.

"Coming off a tough loss and facing Middletown this week will be a very interesting challenge," Reynolds said in a text message Sunday. "We will need to practice hard this week to prepare for another battle this Friday night. Even though we did not play well as a unit, we will just have to overcome the loss and play harder this week."

Hens highlights

It wasn't pretty, but the second-ranked Hens took care of business at home, defeating Maine 26-7.

Keeler's quips from his weekly presser

Things head coach K.C. Keeler liked:

"We played a pretty good football game in a lot of phases: Great defense; Pat looked very sharp; we ran the ball very well (147 yards) considering their run defense."

"Our punting game was amazing. It's neat to see how Ed has grown as a punter. He is so in tune with the game. He is punting as well as anyone in the country. He's a professional. He's very focused on things like wind direction, where's the hash, where we should put the gunners."

"Rob Jones (six catches, 105 yards) is very talented. He's so competitive and plays so hard. It's so important to him. There are not a lot of receivers I'd take in this league over Rob Jones."

Things he didn't like:

"I was disappointed in our execution of the extra points and field goals (one missed PAT, one blocked field goal) from snap to hold. It wasn't all Mike Perry's fault."

"Receivers struggled. We dropped eight balls all year long. Dropped seven in that ball game. I tell the players if you can't play with feverish emotion, you better play with focus. That's where I was disappointed with the receivers."



The University of Delaware will be holding a memorial service for Barbara Curry, professor in the School of Education, on Sunday, Oct. 17, from 2-4 p.m., in the Gore Recital Hall of the Roselle Center for the Performing Arts.

Curry passed away on Sunday, Sept. 26, after a courageous fight with lung can-

"Barbara was a dedicated scholar with wide-ranging interests," said Robert Hampel, interim director of the School of Education. "Her notion of educational leadership drew in creative ways from her deep knowledge of social work and the psychology of adult devel-

Curry taught graduate courses in the master's and doctoral degree programs in educational leadership and since 2005, she was coordinator for the Ed.D. specialization in higher education. She was also an affiliated faculty member of the Department of Women's Studies.

"Throughout her 20-year career as a higher education professor, she was very dedicated to her students and advisees and mentored them in very supportive and nurturing ways," said Zoubeida Dagher, professor in SOE. "She was passionate about matters of equity and fairness at all educational levels and advocated for them tirelessly in her teaching, scholarship and service."

Curry's research interests included organizational change, women in leadership positions, adult learning, and gender equity. She is the author of Women in Power and a dozen scholarly articles and book chapters. In addition, she

coauthored a children's book, Sweet Words So Brave: The Story of African American Literature.

Before coming to the University in 1990, she worked as a clinical social worker for seven years and as an administrator at Franklin and Marshall

Curry holds a B.A. in sociology from Franklin and Marshall College, a M.S.S.W. in social work from the University of Wisconsin-Madison and an Ed.D. in educational administration from Harvard University.

Friends say she will always

be remembered for her friendly personality, graciousness, kindness, loyalty, courage, inner strength, empathy, keen sense of justice, and great sense of humor.

More than one candidate cited the number of 7,000 home mortgage foreclosures in the last year in Delaware. Johnston would like to see more focus on examining and preventing bad loans. Kowalko has established a Foreclosure Mediation program. Also, he would like to see the timeframe for applying for mediation extended from 15 days to 45 days.

On the subject of the redevelopment of the Chrysler

pleased to report that 90% of the debris will be recycled, and there is a requirement in place to employ Delaware residents at 80%. Kowalko was especially knowledgeable about the dangers of asbestos and benzene contamination. All candidates lamented the loss of tax revenue, but recognized that this development will be good for Newark and good for UD.

Surprisingly, all candidates were in sync on the subject of GLBT rights in Delaware. All agreed on equal rights regardless of sexual orientation, and property by UD, Schooley was supported the recent anti-dis-

crimination clause added to the Delaware Code. All agreed that civil unions between same-sex couples should be permitted, granting marriage benefits to partners. Interestingly, all candidates chose not to endorse same-sex "marriage," some citing separation between church and state.

Infrastructure projects in Delaware was the final topic. All agreed that the Indian River Bridge project was not managed properly. Winegar suggested we need to look at our priorities: sidewalks and curbs, or bridges and roads? Schooley stated we have ignored the storm drainage problem for too long. Kowalko would like to see a light rail system, running through a corridor in the entire state.
