REPORT ON LICENSE TAX LAWS

TO THE GENERAL ASSEMBLY:

Pursuant to Senate Concurrent Resolution No. 8, I am submitting herewith for your consideration an entirely new Act revising the license tax laws relating to manufacturers, merchants and occupations.

I am offering no justification for the principle whereby these taxes are imposed other than the precedent established by the old laws, many of which have been in force for upwards of two generations.

In this Act I have but sought to the best of my ability (1) to correct the inequality and discrimination characteristic of the existing license tax laws, (2) to provide for effective enforcement.

I have so designed the Act that you may fix any rate of taxation without disturbing its fundamental structure and purposes.

By the method of definitions and classification of occupations adopted I roughly estimate that the present number of license taxables will be increased from fifty to one hundred per cent. Based on the rates I have tentatively written into the Act and the means of enforcement employed, I feel justified in the belief that the present State revenue from this license taxation will be increased from one hundred to two hundred per cent.

These results I venture to say will follow largely from the correction of existing inequalities and discrimination. For example, the rates of taxation of the class bearing the heaviest burden under the present law will be slightly decreased while the rates of those enjoying special privileges at present will be increased to a point of equality; those persons who, by reason of existing discrimination but by none other pay no license tax, will be brought within the same classification as others in like situation who are now paying such a tax.

This Act abolishes the office of State Collector of Revenue, which appears to have no well defined functions, and creates the office of State License Investigator with fixed administrative duties and responsibilities.

Without conscious design but by the inexorable force of logic, the conclusion is unavoidable that if we must have this form of taxation its application must be uniform and its burden equitably distributed in accordance with reason and justice.
